Administrative Services is responsible for the activities and actions involved in operating the Parks and Recreation Department including: Personnel, budget management, facility use, policy and procedure development and those other items that do not normally fall within one of the main Department functional areas.

HIGHLIGHTS

- Recruited, trained and supervised and evaluated personnel.
- Administered the 2011 department budget, participated in a variety of budget meetings and prepared the 2012 department budget.
- Reviewed parks and recreation fees and prepared an update to the parks and recreation fee ordinance. Researched new sales tax regulations definitions and applied them to the fees where appropriate. The ordinance was approved by City Council.
- Prepared a draft Parks and Recreation Department Pricing Plan. This
 included completing a reconciliation of every receipt written, accounts
 receivable posting and invoice paid in 2010 and 2011, a review of other
 Washington city fee structures for pool use and picnic shelter
 reservations, compiling and comparing the data and developing pricing
 models. The plan is anticipated to be complete in Spring 2012.
- Prepared and distributed weekly, quarterly and annual departmental reports.
- Prepared Parks and Recreation Advisory Board Agendas and posted them to the city website and provided administrative support at Board meetings.
- Updated and reorganized the parks and recreation portion of the City website and completed regular updates to the department Facebook page.
- Updated and posted the Dare to Care gift catalog on the website.
- Met with a representative from the Olympia American Legion to coordinate a band concert in the park by their organization July 15, 2012.

- Developed the first marketing element for Parks and Recreation Departmental branding.
- Reconciled accounts payable and completed financial deposits.
- The Parks and Recreation Director was appointed to the Washington Recreation and Park Association Executive Board. Participated in Washington Recreation and Park Association Executive Board, Membership Committee and Risk Management program development meetings.
- Began development of a city-wide, comprehensive volunteer policy and procedure handbook.
- Participated in a North Central Washington parks and recreation department directors meetings to discuss common issues ranging from gangs and vandalism to park impact fees and special event permits. Attendees included: Ellensburg, Grandview, Selah, Quincy, Ephrata, Toppenish, Chelan and Yakima.
- Coordinated moving departmental operations into the Public Works side of the Public Services Center and completed the move. Revised operational procedures to accommodate the move.

Rental numbers do not include additional general park special event uses such as: Fiestas Mexicanas, Washington State Apple Blossom Festival, Wenatchee Criterion and other community events.

- Completed a number of trainings including: Commercial Drivers' License Supervisors Training, Employee Assistance Program Supervisors Training, Americans with Disabilities Act Training, Sexual Harassment Avoidance and Risk Management in Social Media and others.
- Recreation Supervisor Caryl Morrell received the 2011 Honor Fellow Award for over 20 years service to the Washington Recreation and Park Association and the parks and recreation profession.



- Received and reviewed the Special Event Permit applications for the Apple Blossom Festival, Pig Out in the Park, Fiestas Mexicanas, Triple Crown Baseball Tournament, Farmers Markets, Apple Capital Swim Meet, Live For Adventure Race, Salvation Army Week, Wenatchee Twilight Criterion, Chanukah celebrations, fundraisers and others. Worked with event organizers to address logistical and coordination issues of their events.
- Participated in Wenatchee Convention and Visitors Bureau and Wenatchee Valley Sports Council monthly meetings.
- Prepared an agreement between the City and the Wenatchee Valley Sports
 Foundation to provide an avenue to solicit and accept donations for
 specific programs and projects. The agreement was approved by the City
 and Foundation. Developed a donation form to facilitate the process.
 Met with the Foundation to discuss a media campaign. Created letterhead
 for the foundation, created a work study brochure and distributed it to
 universities.
- Participated in Washington Recreation and Park Association Conference Planning Committee meetings and hosted the annual conference. The conference attracted over 250 parks and recreation professionals to Wenatchee for the four day event.



- Participated in a job fair at Wenatchee Valley College.
- Participated in the process to modify the phone system at the Public Services Center.

- Met with a Tropical Snow vendor to coordinate their use of Pioneer Park during the Summer.
- Met with University Recreation Programs to discuss potential internships with the City and work study opportunity with the City.
- Participated in the efforts to retain the Washington State Special Olympics Winter Games.
- Continued to be a leader in the field of Parks and Recreation by:
 - Provided Pricing Plan information to the Cities of Renton and Toppenish as they would like to use it as an example to develop one of their own.
 - Provided Metropolitan Park District information to the City of Ephrata as they are also considering establishing a district.
 - Provided input to the City of Enumclaw about athletic field concession operations.
 - Assisted the City of Chelan and Town of Waterville with Special Event policies and procedures. They would like to use our process as a model to develop similar policies.
 - Provided program fee information, special event permit process and park naming rights information to the Cities of Chelan, Grandview, Toppenish, Ellensburg, Ephrata and Yakima as they would like to model their programs and policies after ours.
 - Assisted Eastmont Metropolitan Park District with administrative policies and procedures. They would like to use ours as a model to develop their policies and procedures.
- The Director traveled to Eastern Washington University and taught two seminars on Grant Writing and Contracting to 60 potential interns/work study students.

- Prepared an update to financial deposit transmittal forms and prepared new program scholarship and refund procedures.
- The City Council reappointed Laura Jaecks and appointed Barbara Cecie to the Parks and Recreation Advisory Board.
- Worked with vendors for the Apple Cup Soccer Tournament.
- Participated in the Director's retreat and monthly Department Director meetings.
- Participated in the quarterly meeting with Chelan County Public Utility District management staff.
- Participated in the Misawa Sister City welcome.
- Assisted with resolving an intradepartmental personnel issue.
- Prepared draft Metropolitan Park District information including: Sample ballot measure timeline, resolution for a ballot measure, ballot title and election guide language and information sheet. Continued to examine potential funding levels.
- Met with the State Auditor to discuss park shelter, aquatic services, recreation program and Community Center operations.



The chart below shows a comparison of all parks and recreation related revenues and expenses for 2011. Revenues do not include donations that are not receipted by the City and grant reimbursements however, grant related expenses are included in expense numbers. Community Center revenues and expenses are not included as they are in a fund separate from the general fund. The amount of subsidy is the amount required to balance all department expense with revenues. The cost recovery percentage is based on all departmental services. The percent change column is the change from the pervious year.

The City of Wenatchee operates the City Pool in an effort to enhance the quality of life of residents and visitors by providing safe and healthy opportunities for aquatic instruction, recreation, fitness, and safety education. The **Aquatics Division** strives to offer innovative programming that reflects current societal trends, technology, and research findings in a safe, aesthetically pleasing and family friendly environment.

2011 HIGHLIGHTS

- Provided opportunity for economic stimulus and tourism. The Apple Capital Meet and Starlight Meet had an estimated economic impact to the community of \$386,888 (Wenatchee Valley Sports Council).
- Provided opportunity for relaxation, social interaction and engagement, fitness and wellness.
- Increased safety of the youth of the community.
- Provided positive role models.
- Increased participant self esteem and self reliance.
- Increased life skills of participants.



- Provided swimming instruction and opportunities for aquatic recreation, fitness and competitive use.
- The swimming lesson program was featured on the cover of the Washington Recreation and Park Association Magazine.
- Conducted a request for proposals process to determine the feasibility of contracting operations and management of the pool.



- The pool filter brackets, a boiler leak, vacuum hose, vacuum pump and filter sump pump were all repaired. The pool was cleaned, pressure washed and portions painted. A replacement shower pedestal was ordered and is scheduled for installation in the men's locker room.
- Wi Fi service was installed thanks to funding provided by Parks and Recreation Advisory Board member Mark Peterson.
- Met with the coordinator of the Live for Adventure Race to work out race day logistics and hosted the event.
- Assisted the City of Prosser, Selah and Ellensburg with pool logistical information. Selah would like to use our operations as a model for their pool.
- Increased awareness of aquatic services by preparing and posting information on the Cable Access TV channel, Facebook page, in the Summer Recreation Activity Guide and on the City website. Distributed pool information at the Family Expo and Youth Sports Fair, through Wenatchee area schools, libraries and media releases.





POOL REVENUES

The Center was constructed through financial support from: Federal Community Development Block Grants, the State of Washington, the City of Wenatchee, the Gates Foundation, Port of Chelan County, Chelan County, Chelan Douglas Community Action Council and the Wenatchee Central Lions Club.


COMMUNITY CENTER HIGHLIGHTS

ONE TIME RENTAL USE AND LICENSE AGREEMENTS

- Along with regular programming and activities such as the Indoor Playground, After School Action, Food Bank, Head Start, Literacy Council and Wenatchee Valley College programs, the Center hosted a number of special events including:
 - Citizenship Naturalization Ceremonies
 - Misawa Sister City delegation welcome
 - NCWW Luncheon
 - Thrivent Food Distribution events
 - American Red Cross Blood Drive
 - Veterans Services Garage Sale
 - Central Patriotic Council
 - WAVA Student Testing
 - Marine Corps League meetings
 - Toys for Tots collection
 - Homeless housing meetings
- Prepared license agreement extensions for Missio Dei Church, Wenatchee Valley College, Chelan Douglas Community Action and Chelan Douglas Literacy Council. The agreements were all approved.
- Prepared a license agreement with Real Life Church for use of the Community Center. It is scheduled for consideration in early 2012.



- Calculated the annual CPI adjustment for the Head Start Lease and provided it to the Finance Department for implementation. The 3.7% rate adjustment began in September.
- With the Finance Department and City Attorney, reviewed Leasehold Tax collection requirements for lessees.
- Based on current agreements, leased use revenue of the Community Center is estimated to increase by 61% in 2012.
- One time rental revenue declined sharply in 2011.

• Several factors have influenced the decline in one time rental activity including: A shift from one time use to leases for long term renters; inflated numbers in 2009 from federal stimulus funded activities; decline in use from governmental agencies due to agency budget reductions. Rates were reduced to help encourage rental activity.

- Received a \$1,000 "surprise" grant from the Community Foundation of North Central Washington.
- Prepared Board meeting agenda packets, posted the to the city website and provided administrative support at meetings.
- Formatted and prepared the draft 2012 Wenatchee Valley Community Development Association Board budget.
- Revised the Subsidized Rental Program polices and application.
- Prepared a financial audit policy and procedure. The policy was adopted and implemented.
- The Board conducted its annual audit of the non-profit financial records. The audit had no findings.
- The City Council appointed Amy Hefner and Christie Lamountain and reappointed Julie Kagele, Jerry Paine and Mary Jane Gurnard to the Board.

ADDITIONAL ACTIVITES

Completed several repairs and improvement projects at the Center including:

VETERANS HALL: Painted the interior, installed a threshold in the closet,

replaced door locks to improve security, repaired vandalized gutter downspouts, repaired shingle damage

caused by ice dams.

SOCIAL HALL: Repaired the stove and the building's heating system,

Replaced toilet paper spindles as, despite locking dispensers, people regularly steal the toilet tissue and

sometimes also the plastic spindles.

GENERAL: Volunteers and AmeriCorps members constructed picnic

tables, community garden fencing, cleaned flower beds and placed 6 yards of donated beauty bark. Designated additional handicapped parking spaces to help address parking issues. Repaired the Community Garden Fence after a person crashed their car into a trailer parked on

the street causing it to smash into the fence.

- Reviewed the Revised Code of Washington section RCW 73.04.070 as it relates to Veteran's meeting halls.
- The Veterans reported that a Navy plaque in the Veterans Hall was stolen/ missing. The facility was locked and there were no rentals during that time.
- Reviewed a proposal from the Veterans to construct memorabilia cases and paint a mural inside the Veteran's Hall.
- Completed the Community Center Supervisor's annual performance evaluation.
- Prepared and submitted a grant application with the Charlotte Martin Foundation to establish badminton and pickleball programs and cover the cost of facility rentals.
- Obtained cost estimates for Social Hall floor insulation and window coverings for two projected 2012 grant applications.
- All of the Community Garden beds were allocated. The gardeners were generally enthusiastic about the planting season despite the cool Spring and ongoing vandalism of the garden.
- Stained glass window panels in the Social Hall were discovered broken.

- Began the process of developing a comprehensive policy and procedure manual as a part of a continuity of business plan for all Community Center operations
- Increased awareness of the Community Center by preparing promotional material and posting it on the cable access television channel; posted information on the City website, intranet site and Facebook Page; distributed brochures at the Town Toyota Center Family Expo and creatied listings in the Parks and Recreation Summer Activity Guide; Updated the Center lobby computer display to promote upcoming programs and included a directory of building tenants.
- Reviewed the Community Center facility operational schedule, staffing, fees, police security and insurance requirements. Consulted with the City Police Department and insurance provider for input. Modified the rental policies and updated and distributed rental forms.
- Met with the Fire Chief to discuss evacuation procedures for the Center. The Center procedures will be used as a model for other City facilities.
- Parking enforcement was conducted at the Center during Food Bank operations to help educate patrons on how to park legally.

The **Planning and Development** function of the Department includes responsibility for planning for the future growth of the parks and recreation system. Major activities include: Determining land acquisition and facility development needs, capital planning, obtaining financing to implement the projects through grants or other means, conducting specific park area and special studies and completing development project bid specifications.

HIGHLIGHTS

GRANT APPLICATIONS

- Developed and submitted proposals and worked with the Washington Recreation and Park Association's State Lobbyist to promote several grant proposals in hopes that at least one may receive funding by the State. The applications are longshots to receive funding, but worth a try. In general terms, the applications include:
 - A \$1,200,000 request for the upgrade of park wading pools in Pennsylvania, Kiwanis/Methow and Washington Parks and construction of a new splash pad at Lincoln Park.
 - A \$605,000 request to replace the existing restroom in Pennsylvania Park, add restrooms in Kiwanis/Methow and Locomotive Parks and extend sewer lines and construct a restroom at the proposed Saddle Rock Trailhead.
 - A \$910,000 request to construct a trailhead, design and install interpretive signs, complete trail access improvements and restore habitat areas at Saddle Rock.
 - A \$2,000,000 request to complete the renovation of Recreation Park.
- Prepared and submitted an Ecology/Water Quality Grant. If successful, the application would provide funding assistance for dog off leash area signs, dog owner education signs in natural areas, bags and dog waste stations for natural areas and funding of maintenance personnel to empty waste stations. This may help address some of the dog related issues that are occurring in the Wenatchee Foothills.

- Prepared a Department of Natural Resources Community Forestry Assistance Grant proposal. The proposal would provide funding assistance to select a consultant and complete a public outreach effort for a comprehensive update to the City Tree Ordinance.
- Prepared a waiver of retroactivity request for a Foothills North Acquisition Project and received notification of approval from the State Recreation and Conservation Office. A grant application for the project is anticipated to be submitted in Spring 2012.
- Began preparation of cost estimates for a 2012 Community Development Block Grant application for a Chase Park play area and accessibility project.
- Received notice that the \$342,620 Washington Wildlife and Recreation Program Grant completed in 2010 for the acquisition of Saddle Rock was successful. Worked with the Recreation and Conservation Office staff to establish project milestones. The grant agreement was prepared and approved, progress reports completed, title insurance obtained, deed of right prepared and filed, appraisal and review appraisal completed and grant billing prepared. Received approval from the State for amendment to grant budget. The amendment does not change the grant amount, but the way the funds are allocated within the grant. Through this process, more revenue will be able to be retained by the City. The grant project is anticipated to be completed by May 2012.



SADDLE ROCK ACQUISISTION

- The Department of Natural Resources unanimously approved the Saddle Rock purchase sale agreement. The Wenatchee World completed a follow up article, KPQ ran a story and the Wenatchee Business Journal prepared an article. The articles were picked up by the Associated Press and appeared in publications from Seattle to England.
- Worked with the Chelan Douglas Land Trust to coordinate the Saddle Rock acquisition celebration. Over 90 people attended the event. Assembled materials, printed the program, promoted the event on KOHO and KPQ and worked with the Chelan Douglas Land Trust to conduct the event.



- Met with the Chelan County Sherriff and officers, City Police Chief and captains, Fire Chief, Chelan County Emergency Services Officers and Public Works Director to discuss Saddle Rock emergency response and ownership. Completed follow up with the Chelan Douglas Land Trust.
- Worked with the Chelan Douglas Land Trust and Public Works
 Department to develop a project approval process for small
 stewardship projects on Saddle Rock and the development of a
 Stewardship Plan for the property. Completed a preliminary design for
 the entry sign.
- Met with the Engineering Department to discuss strategy for the submission of a \$500,000 Department of Ecology Integrated Planning Grant. The application was completed and submitted for consideration. Notification of award is anticipated in early 2012. Received a strong letter of support from the Department of Ecology for our efforts on the acquisition project.
- Met with Public Works and Ecology, edited the Interim Management Plan and Strategy for Saddle Rock Mine Waste Rock Remediation document and sent it to the Department of Ecology.
- Working through the City Attorney, had exceptions removed from the Saddle Rock title.

• At multiple, meetings with the Wenatchee School District, Project Groundwork, Appleatchee, Dry Gulch Reserve, Chelan County, Chelan Douglas Land Trust, and the City Engineering and Public Works Departments discussed parking options and improvement ideas for the end of Circle Street. A temporary solution was approved by the Wenatchee School Board that may help solve parking issues until a full trailhead (below) can be developed. We are anticipating submitting a RCO Grant application in 2012 to construct the first phase of the permanent trailhead in 2013 if funded. The temporary trailhead is scheduled for construction in



2012.

- Worked with the Chelan Douglas Land Trust and Park Maintenance to coordinate dog waste station installation and trash pick up at Saddle Rock.
- Provided a copy of the Saddle Rock rules to the Association of Washington Cities for comment.

PLANNING

- Completed the process to create the 2012-18 Parks, Recreation and Open Space Comprehensive Plan. The plan is scheduled for adoption by the City Council in early 2012.
- Completed preparation and adoption of the Parks Design Standards and Development Policies.

- Updated the Parks and Recreation Capital Facilities Plan.
- Continued to meet with the Row and Paddle Club and Chelan County
 Public Utility District staff to discuss the Paddler Point Project.

CONSERVATION FINANCE PROJECT

- Worked with the Trust for Public Lands to complete a Conservation Financing Study. Posted the plan to the web site.
- Prepared 216 budget alternatives, staffing outlines and facility listings for potential MPD funding options. Presented information to the City Council.
- Worked with the Trust for Public Lands, appointed and elected officials, staff and pollsters to develop a draft Metropolitan Park District feasibility poll. The poll is anticipated to occur in the Spring of 2012.

OTHER ACTIVITIES

- Coordinated a clean-up project of Rainbow Park with Wal-Mart.
- Completed the process to formally change the name of Methow Park to Kiwanis Methow Park. Made changes on print and electronic media.



- Received a Notice of Periodic Review from the Department of Ecology for the Hazardous Waste Site known as Rotary Park. Every five years, under the Model Toxics Control Act, Ecology must test sites that have been cleaned up. Based on the information collected during their periodic review, the park meets the requirements of Chapter 173-340 WAC and the remedy appears to be protective of human health and the environment. The next test is scheduled to occur in 2016.
- The City received it's 5th Tree City USA Award. Submitted application for the 2011 award.
- Met with the Applesox to discuss the Recreation Park Project.

- Continued to work with the Community For Wenatchee Valley Skateparks on the Pioneer Skate Court mural and other projects. The mural project has been moved over to the Arts Commission to go through the public art process.
- Met with the Engineering Department to coordinate information for the Grandview Historic District Ice Cream Social. Participated in the event.
- Reviewed the new Washington State Recreation and Conservation Office Fiscal Management and Grant Policies.




- Assisted the Engineering Department with action concerning a local business that removed three City street trees.
- Provided park impact fee information to the City of Quincy.
- Met with Wenatchee School District staff and the School Board about ongoing property projects including the Western Hills Park Project.
- Met with Jay Bollinger about issues he is having with the Skyline Drive Overlook.
- Met with the City of Quincy to assist them in their endeavor to construct an amphitheater to accommodate outdoor entertainment.
- Provided the community forestry plan and tree inventory information to the State Department of Natural Resources to help them improve the Community Forestry Assistance Grant Program.
- Met with the Engineering Department and Washington State Department of Transportation about the George Sellar Bridge project. Provided park design criteria and mitigation information to the Department of Transportation. The \$100,000 that we negotiated for park improvements may be coming to the City this year.

- Met with Chelan County, Chelan Douglas Land Trust, City Engineering
 Department and the Trust for Public Lands to discuss pursuit and
 logistics of a Sage Hills Trail Head Partnership Project.
- Assisted the City of Spokane with Community Forestry Program information.
- The Senate passed the Real Estate Excise Tax Flexibility Bill, which allows cities and counties to use up to \$1 million of their existing Real Estate Excise Tax collections to pay for the maintenance and operation of parks and other facilities.
- Received a letter from the State RCO outlining the legal constraints of closing parks and recreation facilities that have been funded by the RCO. Facilities that have received funding include: Saddle Rock, Day Drive and Horse lake Trailheads, Rotary Park, City Pool, Lincoln Park, Pioneer Park, and the Columbia River small craft boat dock.
- Met with the Wenatchee School District Superintendent to discuss property related projects. Provided recreation park construction cost and plan materials to the Superintendent.



- Assisted a private developer pursuing constructing a coffee bar with dog off leash area along the waterfront.
- Worked with Wenatchee Soccer Club to curtail vehicles parking on the grass in Wenatchi Park.

- Participated with the Engineering Department on moving forward the Western Hills Park improvement/flood mitigation/soil remediation project.
- Met with Kiwanis to discuss a possible improvement project in Methow Park for the soccer field and some additional spring clean up work. The Kiwanis Club implemented improvements.
- Coordinated Parks Facilities Committee meetings.
- Completed follow up with FIDO on the off leash area project.



- Met with a Wenatchee Velo representative and pool supporter to discuss parks and recreation projects, trailheads and bike trails.
- Worked with the Public Works Department to complete the replacement of the Pioneer Park play equipment.



The City of Wenatchee provides safe, quality leisure services in the most cost effective manner possible to the community. The **Recreation Division** is striving to provide a comprehensive offering of recreation opportunities for all ages and ability levels within its budgetary means. The following provides information about the programs offered in 2011.

ATHLETICS


Skyhawks Basketball Camp

Skyhawks basketball breaks down this exhilarating sport into fundamental skills that all athletes, no matter their ability level, need to succeed. Coaches led athletes through game-speed drills and exercises, focusing on ball handling, passing, shooting, defense, and rebounding. Developing a refined player who knows how to combine these skills is the goal of the Skyhawks Basketball Camp. All participants received a basketball, t-shirt, and a merit award. The week long camp was held at Foothills Middle School.

Skyhawks Soccer Camp

The camp taught young athletes the fundamental skills of soccer through fun games and exercises. Participants tested their new expertise in skills and strategy through interactive group activities and scrimmages.







Skyhawks Tiny Hawk Soccer Camp

Tiny Hawks Camp was designed for beginner soccer players ages 3 and 4. It focused on dribbling, passing, shooting and ball control. Campers learned life skills such as teamwork and sportsmanship while making new friends and improving their sport skills.





Skyhawks Mini-Hawk Camp

The Mini-Hawk program helped young children explore soccer, baseball, and basketball in a day camp setting. The camp was held at Walla Walla Point Park.

Skyhawks Multi-Sport Camp

This multi-sport program was developed to give children ages 7 to 10 a positive first step into athletics. The essentials of baseball, flag football and soccer were taught in a safe, structured environment with lots of encouragement and a focus on fun.

Hershey Track and Field

The National Hershey Track and Field program is for boys and girls ages 9 to 14. The program is designed to promote physical fitness and reduce sedentary behaviors. It is held over a four week period, three days per week at Wenatchee High School.



Youth Tennis Lessons

Youth Tennis lessons were held over a three week period at Walla Walla Point Park. Lessons focused on the fundamentals of tennis, including basic ground strokes (forehand, backhand), overhead and serve and volley-play. Instruction is designed to teach the basics of tennis in a fun and exciting manner.

Women's Volleyball League

100 participants registered and played in the competitive women's volleyball league. The league was held at Foothills Middle School on Tuesday evenings in the late Winter and early Spring.

Youth Recreational Basketball

The Youth Recreational Basketball program is a fun, introductory basketball program for children in third through fifth grades. The program is designed to refine basketball skills and techniques. The program was held October through December in Wenatchee School District gymnasiums. Practices were held in the evenings



during the week with competitions on Saturdays.

YOUTH RECREATION



After School Action

This fun, after school program is held at the Community Center during the school year. This year, the program was reduced from Monday through Friday to Monday and Wednesday from 3:30-5:30pm to respond to changing budget conditions. The free program gives kids a chance to socialize and participate in supervised recreation activities. Activities include: Video games, computer use, field trips, homework help, sports, games, snacks, special projects, and other activities and events.

Indoor Playground

Indoor Playground is an extremely popular program that provides opportunities for toddlers and their parents to play and socialize in a warm place during the cold winter months. The program was held at the Wenatchee Community Center on Monday and Wednesday mornings from 10:00am to Noon. This program was reduced by one



day per week in 2011 to adjust to changing budget conditions. A wide variety of toys are provided along with coffee and tea for the adults.

Summer Day Camp

The Summer Day Camp program was held over a ten week period starting in June after school was dismissed for the year. Activities included field trips, arts and crafts, games, swimming, indoor and outdoor activities and much more. The program was for children exiting Kindergarten through 5th grade. It was based in the Head Start Building on the Community Center Campus. The day camp program was challenged this summer due to the mechanical failure of two of the three parks and recreation vehicles.



OUTDOOR PROGRAMS

Wading Pool Program

The park wading pool program has been in existence since the 1960's.



Recreation staff lead fun activities including: Games, arts and crafts and wading pool activities. The free program provides a cool respite from the Summer heat and safe, supervised activities for children. The program was conducted Monday through Friday from 1:00-5:00pm at Pennsylvania, Washington and Methow Parks.

Spring Break Paddle Camp

The Spring Break Paddle Camp was a new program offered in conjunction with the Wenatchee Row and Paddle Club. 4th and 5th grade participants learned the techniques of paddling kayaks and canoes on the Columbia River.



Family Outdoor Adventures

This program was a variation on the popular Spring Family Hike Series with the added benefit of water oriented recreation. The free trips were designed to introduce participants to some of the outdoor recreation opportunities in and around Wenatchee. Washington State Park volunteers guided hikers along family friendly trails in the Horan Natural Area and Squilchuck State Park while sharing fun and interesting information. On alternate weekends, volunteers from the Wenatchee Row and Paddle Club taught the basics of paddling canoes and kayaks on land and the Columbia River.



Guided Snow Shoe Hikes For Families



This was a new program that proved to be very popular. Snowshoes were provided through a grant received from the Go Play Outside Alliance of Washington. These trips taught beginners the basics of snowshoeing while exploring family friendly trails in Squilchuck State Park. Hikes were held on Saturdays in January and February.



Junior Rowing Camp

The City partnered with the Wenatchee Row and Paddle Club to offer this new program for participants 14 to 18 years old. In this program, participants learned the fundamentals of sweep style rowing as well as canoe and kayak paddling.

SPECIAL NEEDS PROGRAMS

Special Needs Social Program

The Special Needs Social Program is supported through a grant from the Chelan Douglas Developmental Disabilities Program. It is designed to be a unique recreational opportunity for individuals with special needs to build relationships and participate in

community events. Activities occur approximately twice each month at various locations in the Wenatchee Valley and beyond. Some of the activities conducted this year included: Trips to the Chelan County Fair, Wenatchee Super Oval, Wenatchee Applesox and



Wild Games, dances and socials. A highlight of the year was a boat trip aboard the Lady of the Lake. For most participants, this was the first time they had ever been on a boat.

Spring and Fall Into Fitness

Spring Into Fitness was a new exercise program for participants with special needs. Both the Spring and Fall fitness programs are designed to help participants stay in shape in between Special Olympics sport seasons.

Polar Bear Plunge

The Polar Bear Plunge is a unique opportunity for individuals, organizations, and businesses to support local Special Olympic athletes by jumping or slowly crawling into the frigid waters of the Columbia River. On February 19th, 28 individuals took the plunge. Through their efforts, a record amount of over \$12,600 was generated to support local athletes.



Special Olympic Sports

Special Olympics was founded on the belief that all individuals with cognitive disabilities can benefit from athletic activities. The City coordinated and coached several Special Olympic sport programs for local athletes including: Alpine and Nordic skiing, snowboarding, softball, golf, cycling, basketball, figure skating, speed skating, soccer and track and field. Teams practiced once or twice per week and traveled throughout the State for regional and State competitions. The golf team won the gold medal in the State competition.

SPECIAL EVENTS

Café Mela Summer Concert Series

In a continuing effort to unite the community provide family friendly activities, the Parks and Recreation Department and Café partnered provide 11 free outdoor concerts every Friday the night during the Summer Centennial Park stage. 19 bands performed.



Jack-o-Lantern Jump

Subway Halloween Carnival

An estimated 2,350 boys, ghouls and their parents gathered on Halloween for a 'spooktacular' time at the free Subway Halloween Carnival. Participants came in costume and played carnival games, ate treats and made crafts. The carnival is designed to be a safe and fun way to spend Halloween. The carnival was held at the Convention Center.

Washington State Special Olympics Winter Games

Athletes from across the Pacific Northwest came to the Wenatchee Valley March 4th through 6th and competed in alpine skiing, snowboarding, figure and speed skating, Nordic skiing and basketball.



The games attracted 1,108 registered athletes, 300 coaches, 700 volunteers and 2,500 family members and friends. The Jan Holder Olympic Town started the event at the Town Toyota Center. Following the opening ceremonies at the Town Toyota Center, athletic competitions were held at Mission Ridge, the Leavenworth Sportsmen's Club,

eight Wenatchee and East Wenatchee School District Gymnasiums and the Town Toyota Center Community Rink.

Subway Movie in the Park Series

Three evening movies were presented at Lincoln Park in September and October. The movies started at dusk and included: Despicable Me, Little Rascals and Toy Story 3. The new Lincoln Park site proved to be extremely popular with the highest participation levels that the program has ever experienced.





Independence Day Celebration

The Independence Day Celebration was another success despite the windy day. An estimated 10,000 people attended the event in Walla Walla Point Park enjoying the food and music while the entire valley got to view the fireworks display. The event was made possible through the solicitation and receipt of over \$18,000 in donations. In addition to serving the region, the event attracted tourists from across the State.

- Successfully completed the 2011 Association of Washington Cities Wellcity Award application. The
 City now qualifies for a 2% reduction in health insurance premiums in 2012 equaling an estimated
 \$56,000.
- The City was featured in the Association of Washington Cities Wellness Works Winter 2010-11 magazine for receiving the Golden Apple Award for best practices in healthy city workplaces.
- Recruited, trained and supervised program volunteers for Youth Basketball, Special Olympics, Halloween and other programs and events. Prepared and sent thank you cards to volunteers.
- Assisted with the coordination of the O'Terry's Softball Tournament.
- Participated in the David Thompson Brigade Program wrap up meeting, Row and Paddle Club retreat and planning committee meetings.
- Assisted residents interested in establishing a local paintball league and a bass fishing tournament.
