**Background:** At the February 9<sup>th</sup> meeting of the City Council, members of the City's Diversity Advisory Committee read their statement in opposition to the President's Executive Orders that were contrary to the Committee's mission to foster diversity, equity and inclusion for the City of Wenatchee. At that time, they noted that they were working on a Welcoming Statement that could be utilized by the City of Wenatchee to provide comfort for the area's diverse populations. Since they read their statement on February 9, they have spent time becoming educated on our Police Department's policies and bringing community feedback to the Diversity Advisory Committee for the purposes of informing and crafting the Welcoming Resolution. #### Overview:

• On January 12, 2017, City Council authorized the Mayor to sign the Collective Bargaining Agreement (CBA) between the City of Wenatchee and AFSCME, Local 846 for the period January 1, 2017 through December 31, 2020.

- It was noted then that Appendix A individual wage adjustments requested by the Union will be addressed separately by a Wage Review Committee.
- The Wage Review Committee reviewed job descriptions and comparable wages and agreed that nine (9) classifications needed adjustment of the eighteen (18) classifications requested by the Union for review.
- Wage Review Committee discussions were completed by the March 31 deadline allowing for approved changes to be applied retroactively to January 1, 2017.
- Individual wage adjustment recommendations and a financial impact analysis were reviewed with Finance and Department Director's for budget consideration.
- Final management recommendations for the AFSCME Local 846 Wage Schedule are highlighted in the attached Appendix A.

#### I. OVERVIEW

Chelan County District Court provides probation services for the City of Wenatchee's offenders. There is an existing contract that uses a complex calculation to determine the fees that the County charges to the City. The County's costs for probation services have increased, prompting them to request the City increase its contribution.

The proposed contract amendment allows for a flat annual \$45,000 fee to be charged in 2017 and 2018. This is equal to the amount the City budgeted for 2017 probation services. The amendment also allows the County to provide annual reports, rather than quarterly reports, and defines the caseload reports requested by legal counsel.

#### II. <u>ACTION REQUESTED</u>

Staff requests a motion for the City Council to authorize the Mayor to sign the First Amendment to Interlocal Agreement for Providing District Court Services Between Chelan County and the City of Wenatchee.

#### III. FISCAL IMPACT Submitted to the Finance Committee: YES

None. The 2017 budget already includes \$45,000 for Probation Services. Prior Probation Service fees have ranged from \$25,000 to \$42,000 over the past six years.

# FIRST AMENDMENT TO INTERLOCAL AGREEMENT FOR PROVIDING DISTRICT COURT SERVICES BETWEEN CHELAN COUNTY AND THE CITY OF WENATCHEE

THIS FIRST AMENDMENT TO INTERLOCAL AGREEMENT FOR PROVIDING OF DISTRICT COURT SERVICES ("Amendment") is entered into between Chelan County ("County"), a political subdivision of the State of Washington, the City of Wenatchee ("City"), a non-charter code city of the State of Washington, and the Chelan County District Court ("Court") acting through its presiding judge, jointly referred to as "Parties."

#### **WITNESSETH:**

WHEREAS, the City and County are currently parties to an Interlocal Agreement for the use of Chelan County District Court services by the City of Wenatchee that was signed on December 1, 2014, and expires on December 31, 2018 ("Existing Agreement");

WHEREAS, the Existing Agreement required the Parties to review the Existing Agreement no later than December 31, 2016, to determine if the Agreement should be amended;

WHEREAS, the Parties did review the Existing Agreement and determined that the Existing Agreement should be amended as it relates to probation services and probation fees as it did not appear as if the City was paying its pro rata share for probation services, and the County maintains its reporting requirements are too burdensome;

WHEREAS, the City and County wish to amend the Existing Agreement as it relates to probation services and probation fees only;

NOW THEREFORE, the Parties agree as follows:

#### 1. AMENDMENT

The Parties agree to amend Terms 8(b), 8(c), and 8(d) of the Existing Agreement relating to probation services and probation fees to read in their entirety as follows:

#### b. Determination of Cases being Supervised

At the end of each year (December 31), Probation shall determine how many City cases are being supervised by Probation for that year ("Probation Case"), which shall not include any case that was on "inactive status."

- i. For purposes of this section "inactive status" means any case:
  - a. That is archived for six consecutive months or more;

- b. Where the Court has terminated supervision by Probation prior to March 31; or
- c. Where jurisdiction for probation supervision has expired prior to March 31.
- ii. For purpose of this section multiple cause numbers for the same individual that arose from the same incident shall be deemed one "Probation Case." For example, if an individual has been charged with DUI and DWLS 3 under cause number 1234 WCA with a violation date of January 1, 2010, and has also been charged with an MIP under cause number 5678 WCA with a violation date of January 1, 2010 that arose from the same incident as 1234 WCA, then 1234 WCA and 5678 WCA are deemed one case for purposes of determining a "Probation Case."

#### c. Fees

#### i. Service Fee

For the years 2017 and 2018, an annual service fee of \$45,000 shall be assessed by the County to be paid by the City for all Probation Cases. The County shall invoice the City \$11,250 for the annual service fee on a quarterly basis. Payment by the City shall be due thirty (30) days after receipt of the County's invoice.

#### ii. Offender Fee

At the end of each calendar year, the County shall determine the City's share of costs related to probation services. If the City's costs exceed the probation service fees collected from City offenders, then the County may amend its Chelan County Probation Department Policy Manual to increase probation service fees assessed to City offenders to offset any shortfalls between the fees paid by the City and the costs of the County related to City offenders. In no event shall the County charge more than allowed by law for probation service fees to any City offender.

#### d. Annual Report

By January 15 of each year, Probation shall provide the City with a written report for the Probation Cases of the previous year.

- i. The written report shall contain the following information:
  - a. The name of the individual being supervised by Probation, the cause number or numbers that Probation is monitoring, and whether the monitoring is supervised probation or bench probation;
  - b. The total amount of probation fees it has charged to offenders for City cases;

- c. The total amount of probation fees it has collected from offenders for City cases.
- ii. For purposes of this section:
  - a. "Bench probation" means any Probation Case where Probation is providing bench probation services as defined by the Chelan County Probation Department Policy Manual.
  - b. "Supervised probation" means any Probation Case where Probation is providing probations services other than bench probation.

#### 2. NO OTHER AMENDMENTS

Other than the amendments stated herein, all of the terms, obligations, and covenants contained in the Existing Agreement shall remain in full force and effect.

#### 3. **COUNTERPARTS**

This Amendment may be executed in any number of counterparts, each of which, when so executed and delivered shall be an original, but such counterparts shall together constitute but one and the same.

#### 4. **EFFECTIVE DATE**

Pursuant to RCW 39.34.040, this Amendment shall become effective when the City files this Amendment with its City Clerk and posts it on its website, and the County records this Amendment with its County Auditor.

#### I. PROJECT AND PROCESS OVERVIEW

This West Springwater Avenue Sewer Extension project installed approximately 2,380 feet of new 8-inch diameter sanitary sewer pipe in Springwater Avenue west of Western Avenue. The project constructed main line pipes, manholes, and 4 inch side-sewer pipes to developed properties. Properties that did not authorize construction easements were provided with connection points but those connection points were terminated at the right-of-way line. Any further extension of sewer mains or side sewers into said properties will be at the property owner's expense. Sewer stubs were not installed for vacant properties as the appropriate location(s) cannot be determined absent a defined site use and/or site plan. Design, construction, and testing expenditures for the project totaled \$519,754.56. Costs were paid out of the Sewer Fund.

RH2 Engineering was tasked with updating the initial project engineering report to reflect the cost changes and generate an assessment role to use in assigning proportional connection charges to benefitting properties. Only those currently unserved properties fronting on Springwater, or those that are accessed solely from Springwater via driveways and access easements were considered to have sewer available and subsequently benefit from the new infrastructure.

The methodology for the cost determinations was based on Equivalent Residential Units (ERU's). Existing, developed, single-family dwellings built on lots that cannot be further subdivided were assigned a single ERU. Properties that can be further subdivided were assigned ERU's based on their area along with the existing zoning designations which define the maximum allowable lot density for the property. At present, there are no platting actions under way for any of the larger, subdivideable properties nor have any applications for subdivision been submitted. As part of the determination of the appropriate number of ERU's for subdivideable properties, allowances were made for anticipated dedication of right-of-way area. To avoid a disproportionate allocation of costs toward the irregularly shaped, subdivideable properties, that area was excluded from the ERU calculation. The resulting ERU's were rounded to the nearest whole number.

To determine the appropriate connection charge amounts, the total project cost was divided by the calculated number of ERU's in the drainage basin served by the new Springwater system. That cost per ERU was multiplied by the number of ERU's for a given property to calculate the dollar value of its connection charge. The recommended charges are included in the proposed ordinance as Exhibit A. A map of the affected properties is also attached for reference.

Upon establishment of a hearing date per Resolution 2017-18, an advertisement was posted in the Wenatchee World and letters of notification were mailed out to the individual property owners of record as listed with the Chelan County Assessor's office. Those property owners were advised of the hearing date, provided with the recommended cost breakdown, and invited to attend the hearing. One letter was returned as undeliverable by the Post Office. Although not indicated in the Assessor's records, that particular undeveloped property, referenced in Exhibit A as 2119 Springwater, appears to currently be owned by the adjacent property of 2121 Springwater. That property has a connection fee associated with a single ERU.

Some property owners have expressed interest in connecting to the new sewer immediately due to the failing condition of existing septic systems. In order to expedite service to those residents, notices to title will not be filed for properties whose owners are seeking immediate service and pay the costs outlined in Exhibit A. Notices to title will be filed with the Office of the County Assessor for the remaining properties by the end of May 2017.

#### **ORDINANCE NO. 2017-07**

**AN ORDINANCE,** approving and confirming a reasonable connection charge to connect to the public sewer system of the City of Wenatchee related to the West Springwater Avenue Sewer Extension.

WHEREAS, multiple, existing, single-family residential properties located along the south side of Springwater Avenue, as well as along Woodward Avenue and Cypress Lane (a private roadway) currently generate sanitary sewer wastewater disposed of solely through onsite, privately-owned septic systems; and

WHEREAS, large tracts of undeveloped land, approximately six to 23-acres in size, exist on the north and south sides of Springwater Avenue adjacent to the irrigation canal; and

WHEREAS, residential land subdivisions of said tracts of undeveloped land having established Residential Single-Family (RS) and / or Residential Low (RL) zoning designations have been conceptually proposed; and

WHEREAS, additional undeveloped parcels, approximately one to 2.3-acres in size, exist with the potential to be further subdivided into residential lots having densities consistent with Residential Low (RL) zoning criteria; and

WHEREAS, the City constructed the West Springwater Avenue Sewer Extension for the benefit of each of these properties; and

**WHEREAS,** equitable shares of the cost to build the West Springwater Avenue Sewer Extension have been computed the Equivalent Residential Units (ERU's); and

**WHEREAS,** Exhibit "A" — Shares Per Benefitted Property, identifies the current owner, address, tax parcel number, and legal description of each parcel of land within the area benefitted by the West Springwater Avenue Sewer Extension subject to this ordinance; and

**WHEREAS,** in Exhibit "A" – Shares per Benefitted Property, attached hereto, sets forth the reasonable costs to be paid in the future by property owners as their equitable share of the cost of the sewer extension project prior to connecting to the City sewer system as part of abandonment of privately-owned septic systems; and

WHEREAS, Exhibit "A" – Shares per Benefitted Property, attached hereto, sets forth the reasonable costs to be paid in the future by property owners as their equitable share of the cost of the sewer extension upon subdivision of these tracts of land or construction of wastewater generating facilities thereon; and

WHEREAS, the City Engineer of the City of Wenatchee has determined that construction of the West Springwater Avenue Sewer Extension was finally complete on November 16, 2016, and is available for connection as of the date of this ordinance; and

WHEREAS, pursuant to the laws of the State of Washington, specifically RCW 35.92.025 and pursuant to Wenatchee City Code WCC 4.08.036, the City Council of the City of Wenatchee, being the legislative body of said City, may authorize such reasonable connection charge as it determines proper in order that such property owners shall bear their equitable share of the cost of such system; and

WHEREAS, such equitable share may include interest charges applied from the date of construction of the sewer extension, until said property owner connects to the sewer system, or for a period not to exceed ten years, at a rate commensurate with the rate of interest applicable to the City of Wenatchee at the time of construction; and

WHEREAS, an appropriate interest rate at the time of construction applicable to the City based on the U.S. Department of the Treasury certified rate for the month of December 2016 for government agencies is 2.38% per annum for an obligation of up to ten years; and

**WHEREAS,** a duly advertised public hearing was held before the Wenatchee City Council on the 27<sup>th</sup> day of April, 2017 wherein the public and the affected property owners were given an opportunity to be heard.

### NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WENATCHEE DO ORDAIN as follows:

#### SECTION I – CONNECTION

The connection charges for the West Springwater Avenue Sewer Extension as set forth in **Exhibit "A" Shares Per Benefitted Property** for the benefitted properties described in the exhibit, along with any and all interest accrued in accordance with Section II, shall be due and payable in full upon connection of said property to the public sewer system. These charges are in addition to those connection fees outlined in WCC 4.08.036 (1) and WCC 4.08.037 and shall not be considered as partial payment thereof nor applied as credit thereto.

#### SECTION II - INTEREST ACCRUAL

The connection charges for the West Springwater Avenue Sewer Extension shall be subject to interest accruing at the rate of 2.38% per annum from November 16, 2016 and shall be payable as a condition precedent to connecting to the City sewer system. Interest shall cease to accrue upon the earlier of full payment or after ten years from November 16, 2016 and the aggregate amount of interest shall not exceed the equitable share of the cost of the system improvements allocated to the property owners set forth in **Exhibit "A."** 

#### **SECTION III - SUBDIVISION**

The connection charges for the West Springwater Avenue Sewer Extension as set forth in **Exhibit "A"** for the real property listed in the exhibit, along with any and all interest accrued in accordance with Section II, shall be due and payable in full

as a prerequisite condition to any future subdivision of the property or properties described in the exhibit.

#### **SECTION IV - DEVELOPMENT**

The connection charges for the West Springwater Avenue Sewer Extension as set forth in **Exhibit "A"** for the properties listed in the exhibit, along with any and all interest accrued in accordance with Section II, shall be due and payable in full prior to issuance of any building permit for construction of new wastewater generating structures or facilities, reconstruction of existing wastewater generating structures or facilities, or expansion of existing wastewater generating structures or facilities in or upon the property described in the exhibit.

#### SECTION V - RUNS WITH THE LAND

The obligation to pay the connection charges and the accrued interest set forth herein shall run with the land and shall be binding upon the current owners, their successors and assigns.

#### **SECTION VI - SEVERABILITY**

If any one or more of the provisions of this ordinance shall be declared by a court of competent jurisdiction to be contrary to law, then such provision shall be null and void and shall be deemed severable from the remaining provisions of this ordinance and shall in no way affect the validity of the other provisions of this ordinance.

#### **SECTION VII - EFFECTIVE DATE**
