A. Our Valley Our Future Update

Steve Maher provided an overview of the Our Valley Our Future, highlights of the action plan of which Wenatchee is the lead on 24 action items and one "game changer" project, progress over the past nine months, sampling of first year successes, and next steps for Our Valley Our Future, including the transitioning to a non-profit status by January 1, 2019.

B. INFRA Grant Application Overview

The meeting adjourned at 6:22 p.m.

Economic Development Director Steve King, Public Works Director Matt Leonard, Link General Manager Richard DeRock, Chelan-Douglas Transportation Council Executive Director Jeff Wilkens, and Port of Douglas County Representative/RH2 Engineer Erik Howe, presented the Council with the history and plan for the Apple Capital Loop project which includes North Wenatchee Avenue improvements, Confluence Parkway, Wenatchi Landing access and connectivity, SR 28/Eastside Corridor capacity improvements project and a South Wenatchee Loop Trail connection over BNSF railway. The agencies together with the assistance of a grant writer plan to submit an INFRA grant application which is due by November 2. The City will be the applicant and this is a substantial federal request of approximately \$270 million project, and \$161 million potential application which will require an up-front investment of the city on behalf of the region.

The Mayor announced that the finance committee meeting next week will be the initial review of the budget and department requests. The Mayor is optimistic that 100% of property taxes will go to the street fund.

I. OVERVIEW

This design contract covers providing pre-design services for providing corridor and intersection traffic operations modeling, roadway and intersection design, ITS research and design, transit alternative analysis, and public involvement for future improvements on SR 285 North Wenatchee Avenue.

This corridor has been awarded \$23 Million in Connecting Washington funds which includes improvements at Easy Street and US/2 as well as North Wenatchee Avenue. This project will look at further defining and evaluating alternatives for the improvements identified in the SR 285 North Wenatchee Transportation Master Plan. This project will also further analyze the options provided in the North Wenatchee Avenue Form and Function Study which introduced transit queue-jumps and other components.

This project will provide recommendations for prioritizing improvements for North Wenatchee Avenue and to continue the public outreach process for these improvements.

City staff in conjunction with Washington Department of Transportation, Chelan Douglas Transportation Council, and Link Transit have determined KPG to be best qualified, based on proposals and interviews with two engineering firms, to perform engineering services for this project.

The selection process was conducted in accordance with Chapter 39.80 RCW – Contracts for Architectural and Engineering Services.

II. ACTION REQUESTED

Staff recommends the City Council authorize the Mayor to negotiate with KPG. for design services for the SR 285 N. Wen. Ave. Improvements Pre-design (Project No. 1720), and further authorize the Mayor to sign a contract on behalf of the City.

Project Budget

The Finance Committee authorized a budget of \$100,000.00 of funds from the Cities Arterial Street Fund to be used for this pre-design.

I. OVERVIEW

The Washington Street Irrigation Association approached the City to explore the option of extending their irrigation pipeline on Washington Street one block and irrigating Washington Park with irrigation water rather than domestic water. In 2016 the City paid \$11,842.48 for water at the park which includes irrigation as well as water for the wading pool and bathrooms. The City currently has five shares of irrigation water for Washington Park which is currently being used for Pioneer Park. Washington Park was served by an irrigation line that ran down Miller Street which failed a number of years ago.

The cost to extend the pipeline and to make all necessary plumbing modifications is estimated to be approximately \$8,000.00. The estimated irrigation association assessment is expected to be \$250.00 for 2018. The cost to lease shares for Pioneer Park is estimated to be \$525.00 for 2018. This project will also provide for additional water rights to be available for domestic use.

This agreement requires that the Washington Street Irrigation Association notify the City if any improvement is needed that would cost the City more than \$1,000.00 per year. All of the existing domestic water infrastructure will remain in place in-case we need to convert back to using domestic water for irrigation. We are also exploring to see if it would be cost effective to construct a larger filtering facility that would serve additional properties as well.

II. ACTION REQUESTED

Staff recommends the City Council authorize the Mayor to sign an agreement with Washington Street Irrigation Association to provide irrigation water to Washington Park.

III. FISCAL IMPACT Submitted to the Finance Committee Yes (No)

The total estimated project cost of \$8,000.00 will be funded by the current parks maintenance and water utility funds and no budget amendment is currently needed. This project is estimated to save the City's General Fund approximately \$7,500.00 per year which includes the anticipated additional costs for filter maintenance.

IV. PROPOSED PROJECT SCHEDULE

The irrigation line extension is anticipated to be completed this fall to be ready to irrigate with irrigation water in 2018.

AGREEMENT RE: IRRIGATION WATER

AGREEMENT made by and between the City of Wenatchee, a Washington municipal

corporation ("City") and the Washington Street Irrigation Association, an unincorporated

association ("WSIA") related to the provision of irrigation water to the City owned Washington

Park.

RECITALS:

WHEREAS, City owns and operates Washington Park located at 110 South Miller Street,

Wenatchee, Washington, legally described as follows:

The North half of the Northeast quarter of the Northeast quarter of the Northeast quarter of Section 9, Township 22 North, Range 20 East, WM,

Chelan County, Washington, except road rights of way.

Said property consists of approximately 4.11 acres.

Tax parcel number 22 20 09 110 300.

WHEREAS, Washington Park requires a significant amount of irrigation water to maintain

the park and its' landscaping;

WHEREAS, it would be more efficient to use non-potable irrigation water rather than

potable water to maintain the park landscaping; and

WHEREAS, WSIA and City have sufficient water shares in the Wenatchee Reclamation

District system to supply Washington Park with non-potable irrigation water and WSIA has an

adequate supply line to convey water from the Wenatchee Reclamation District canal to

Washington Park to meet some or all of its irrigation needs.

AGREEMENT:

NOW, THEREFORE, the parties agree as follows:

- Water. WSIA agrees to allow the City to connect to its water line conveying non-1. potable irrigation water from the Wenatchee Reclamation District canal to Washington Park for the purposes of irrigating Washington Park. City shall be solely responsible for its's costs to connect to the system and to maintain its' connection to the system. Said costs may include upgrades to existing filtration that are reasonably related to providing the City service as mutually agreed between the parties.
- Usage. City agrees to abide by the reasonable usage rules established from time to 2. time by the Board of WSIA as to amounts of water used and time periods for watering.
- Costs. City agrees to pay its proportionate share in relation to the other members 3. of WSIA of costs for administering, operating, and maintaining the conveyance system of WSIA. Billing shall be invoiced in writing by WSIA and paid by the City within twenty (20) days of receipt. Assessments exceeding One Thousand Dollars (\$1,000.00) to the City in any one year shall be pre-approved by the City.
- Term. This Agreement shall take effect immediately upon execution and remain in 4. effect until terminated by either party upon thirty (30) days advance written notice to the other. The City shall be liable for its proportionate costs in relation to the other members of WSIA up to the date of termination.
- Insurance. WSIA shall maintain a commercial general liability policy of insurance 5. of at least One Million Dollars (\$1,000,000) insuring against personal injury, loss of life, and property damage related to its' system at all times during the term of this Agreement. WSIA shall provide proof of said insurance to City prior to commencement of this Agreement, and thereafter upon reasonable request.

- 6. <u>Books and Records</u>. WSIA shall allow its books and records related to administration, operation, and maintenance of its system to be inspected by City on seven (7) days advance written notice.
- 7. <u>Binding Effect</u>. This Agreement shall be binding upon and inure to the successors and assigns of the parties.
- 8. Merger. There are no other agreements between the City and WSIA other than those set forth herein. Any amendments hereto shall be set forth in writing.
- 9. <u>Authority</u>. The undersigned represent that they have full authority to bind their respective entity to this Agreement and that each entity shall be bound hereby.

I. OVERVIEW

The GSA has issued a request for bids for space for Social Security Administration. Given the City is pursuing constructing a new City Hall inside the Federal Building, city staff recommends securing a lease for use of the existing city hall.

Some investment in the existing building will be required to ensure that it meets the Federal Government specifications. In addition, the building needs to be brought up to class A office space quality. The objective of the city is to create a greater return through a lease compared to selling the building.

The GSA has the objective of entering into a lease in a short time frame which means the City would need to relocate city hall services temporarily. It is likely that the city will have to vacate City Hall 100 days from award which in the earliest case scenario would be approximately the first of February.

If the City was successful in winning the award, the city would enter into negotiations for tenant improvements and modifications to city hall as part of the basic building shell. Architectural services will be necessary to help with this process.

II. ACTION REQUESTED

Staff recommends the City Council authorize the Mayor and staff to submit a bid to the Federal Government for lease of the existing City Hall building.



I. OVERVIEW

The City of Wenatchee adopted a Sewer Comprehensive Plan in June 2017. An extensive Capital Improvements Project (CIP) plan was identified in that document. The CIP included system improvements necessary to provide sanitary sewer service to the Sunnyslope and Olds Station areas. Those improvements consisted of replacement of existing infrastructure to accommodate the higher flows, new main line extensions into existing, developed neighborhoods, construction of a new lift station along with an additional force main across the Wenatchee River.

The first phase of the system expansion included projects referenced in the CIP as FLS1, FG5, FG2 and FG3. These represent the construction of the new Sunnyslope Lift Station and force main, a new 12-inch trunk line in Horan Road and Olds Station Road from the intersection with Chester Kimm to the new lift station, a new 12-inch trunk line through the Chatham Hill neighborhood, and the Sunnyslope Trunk line in Easy Street from Crestview Street to a point west of Sun Valley Drive, south to US 2 where it will parallel the highway alignment and tie to the new Chatham Hill trunk line. The Sunnyslope trunk line project will also extend service in School Street north of Melody Lane.



The new lift station will be capable of pumping 1,150 gpm with the potential to be upgraded to 1,650 gpm at some point in the future should northerly expansion of the UGA ever be desired. The associated force main will include approximately 4,400 feet of 12 inch pipe crossing the Wenatchee River at either SR 285, the railroad trestle, or the pedestrian bridge. The exact alignment will be determined as part of this project.

The Chatham Hill improvements will include the construction of approximately 6,100 feet of 12 inch pipe with two, trenchless borings across US 2 and SR 285. Upon completion of the Chatham hill pipeline, the Sunnyslope Gravity Sewer will build 8 inch, 10 inch, and 12 inch mains totaling just over 6,600 feet in overall length in School Street, Easy Street, and various easement corridors.

City staff issued a Request for Qualifications in September, 2017. Seven submittals were received and, upon completion of a selection matrix, it was determined that RH2 Engineering, Inc. was best qualified to perform engineering services for this project. Selection criteria included qualifications of key personnel, experience with sanitary sewer lift station design & construction, trenchless design & construction, project understanding including method of approach, ability to complete project on time within budget, experience with environmental analysis, documentation and right-of-way acquisition, as well as past projects and references for similar projects completed within the last three years.

II. ACTION REQUESTED

Staff recommends the City Council authorize the Mayor to negotiate with RH2 Engineering, Inc. for design services for the Olds Station Sanitary Sewer Extension Phase 1 (Project No. 1718) and further authorize the Mayor to sign a contract on behalf of the City.

Resolution 2017-48, approved on September 14, 2017, established a public hearing date of September 28, 2017 for final action on the annexation. Notice of the public hearing was published in the Wenatchee World on September 15, 2017.

See Exhibit "A" as depicted in Exhibit "B", attached hereto and incorporated herein by reference as if fully set forth;

and each and every part thereof be and the same is hereby annexed to the City of Wenatchee, State of Washington; and that the corporate limits of the City of Wenatchee be and they are hereby extended so as to include the property and territory hereinbefore fully described. That said property be assessed and taxed at the same rate and on the same basis as the property of the City of Wenatchee is assessed and taxed to pay for the now outstanding indebtedness of the City of Wenatchee contracted prior to or existing at the time of this annexation.

SECTION II

That the property described in Section I hereof be and the same is hereby classified and zoned as North Wenatchee Business District. All such zoning and classification being subject to the provisions of Ordinance No. 2007-34, and all subsequent amendments thereto.

SECTION III

This Ordinance shall take effect from and after its passage on the later of sixty (60) days after publication of such Ordinance once in The Wenatchee World, the same being the official newspaper of the City of Wenatchee, and the Clerk is hereby directed to cause the same to be so publicized, or sixty (60) days from the date notice of the annexation is provided to the Chelan County Treasurer, Assessor, and light, power and gas distribution businesses.


