3. Action Items.

A. Chelan-Douglas Community Action Council Board Representation

Executive Services Director Allison Williams presented the staff report.

Motion by Councilmember Jim Bailey to approve Resolution No. 2017-71, appointing a City Council member as the City of Wenatchee City Council representative on the Chelan-Douglas Community Action Council Board. Councilmember Linda Herald seconded the motion. Motion carried (6-0).

B. Request for Approval of Funding Applications for Engaged Cities Awards
