Harris also expressed concern about high density designation of his neighborhood and concern for ability to rebuild an existing single family residence if there were a fire, etc. Harris also expressed concern about increased traffic in the area created by high density developments.

Elizabeth Nordy, 1344 Springwater, Wenatchee, WA. Nordy advised that she too was concerned about change in zoning designation of her property.

Diana Fine, 1416 Tacoma Street, Wenatchee, WA. Fine expressed gratitude for changing zoning designation that would allow her to rebuild her home if lost by fire, etc. However, she had questions and was concerned about ability to divide property she owns and build new single family residences on her property.

Chair Griffith encouraged interested and affected parties to direct specific questions to staff and to feel free to participate and provide comment when public hearings get started.
