DISCUSSION ITEMS:

A. Ninth Street Queue Lengths

Engineering Services Manager Jacob Huylar and Project Engineer Ryan Harmon provided background information for the Ninth Street Planning Study, and Project Manager Mike Hendricks and Lead Engineer Brett Powell of Perteet presented a power point presentation outlining the purpose of the study, the process which will include evaluating, public outreach, and a final report and recommendations. The recommendation of the consultant at this time is to look at a three-lane permissive left-turn phasing with intersection safety treatments. The estimated full project cost is \$859,000. A partial project cost with phased in improvements is estimated at \$381,000.

B. COVID Financial Impacts

Finance Director Brad Posenjak provided an overview and forecast of the city's current budget and next year's budget with a forecast of revenues and sales taxes being down, at a loss of close to \$900,000 for 2020. With the reserve balance and rainy day fund, the city should be able to absorb this loss; however, it is recommended to slow spending and not fill open positions as much as possible at this time. The budget for 2021 will not include any enhancements in services and with the CPI being less than 1%, there will not be any cost of living increases. It is anticipated that 2021 will incur a deficit of \$800,000.

He also provided an update on the CARES funding application to reimburse the city \$700,000 in costs. The Mayor added that he and Executive Services Director Laura Merrill made a recommendation to the County to include local businesses in their CARES funding disbursements and they agreed.

1. Call to Order, Pledge of Allegiance, and Roll Call. Mayor Frank J. Kuntz called the regular meeting to order at 5:15 p.m. Councilmember Linda Herald led the Pledge of Allegiance. All Councilmembers were present, with Councilmember Keith Huffaker participating via phone.

2. Consent Items:

Motion by Councilmember Jim Bailey to approve agenda, vouchers, and minutes from previous meetings, and for City Council to accept the work performed by the contractor, DW Excavating, on City Project No. 1601 – SR285 Pedestrian Crossing Improvements and further authorize the Mayor to sign the Final Contract Voucher. Councilmember Mark Kulaas seconded the motion. Motion carried (7-0).

3. Presentations:

 Fire Adapted Neighborhood Hero Month Proclamation read by Councilmember Jose Cuevas. Councilmember Cuevas will deliver to Alma Chacon on behalf of CAFÉ and Parque Padrinos.

4. Action Items.

A. Purchase of 2.23 acres of property from the Wenatchee School District for a 60 ft. wide Springwater Avenue right-of-way extension from the west end of the existing Springwater Avenue to the north property line of the School District property (see Exhibit A-3 and A-4 in the attached Agreement)

Public Works Director Rob Jammerman presented the staff report. Council asked questions.

Motion by Councilmember Mark Kulaas for City Council to approve and authorize the Mayor to sign the Real Estate Purchase and Sale Agreement. Councilmember Travis Hornby seconded the motion. Motion carried (7-0).

B. Approval of Ordinance No. 2020-18 amending Chapter 1.46 WCC "Emergency Management Organization" pertaining to the City of Wenatchee's designated emergency organization and adoption of the June 2020 Comprehensive Emergency Management Plan

Executive Services Director Laura Merrill presented the staff report. Emergency Management Representative Stan Smoke was also present. Council asked questions.

Motion by Councilmember Linda Herald for City Council adopt Ordinance No. 2020-18 amending Chapter 1.46 WCC "Emergency Management Organization" and adopt the June 2020 revision of the Comprehensive Emergency Management Plan. Councilmember Jose Cuevas seconded the motion. Motion carried (7-0).

C. City Project 1914 – First Street Bikeway Safety Improvements
Authorization to Award Construction Contract

Engineering Services Manager Jacob Huylar presented the staff report. Council asked questions.

Motion by Councilmember Travis Hornby for the City Council to approve the project budget amendment, award the construction contract for the First Street Bikeway Safety Improvements, Project No. 1914, to Rudnick and Sons LLC in the amount of \$283,054.00, and authorize the Mayor to sign the contract documents. Councilmember Mark Kulaas seconded the motion. Motion carried (7-0).

D. City Project SW20-04 – Unit-Priced Concrete Flatwork Authorization to Award Construction Contract

Engineering Services Manager Jacob Huylar presented the staff report. Council asked questions.

Motion by Councilmember Ruth Esparza for City Council to award the construction contract for the Unit- Priced Concrete Flatwork, Project No. SW20-04, to Black Forest Finishing in the amount of \$295,585.50 and authorize the Mayor to sign the contract documents. Councilmember Jose Cuevas seconded the motion. Motion carried (7-0).

- E. An amendment to the City budget to address a funding change in the Chelan-Douglas Homeless Program funding sources and allocations:
 - A new estimated award of \$1.2 million of State CARES Act funds for an Eviction Assistance Program between the City of Wenatchee and the Washington State Dept.

of Commerce (Commerce) to serve renter households facing eviction due to the COVID-19 crisis.

Housing Programs Coordinator Oliver Crain presented the staff report. Council asked questions.

Motion by Councilmember Linda Herald for City Council to accept the Chelan-Douglas Homeless Housing Task Force's (HTF) recommendations and authorize the Mayor to enter into a new grant agreement between the Commerce and the City of Wenatchee for the Eviction Assistance Program funds, and to enter into a new grant agreement or agreements between the City of Wenatchee and a subgrantee or subgrantees recommended by the HTF to manage the program and distribute assistance to households in need. Councilmember Jim Bailey seconded the motion. Motion carried (7-0).

- **5. Public Hearing Items.** The Mayor explained the public hearing process.
 - F. Ordinance No. 2020-17 2021-2026 Transportation Improvement Program

City Engineer Gary Owen presented the staff report. Council asked questions and commented.

The Mayor then asked for public comment. There was no one who wished to comment.

Motion by Councilmember Mark Kulaas for City Council to approve Ordinance No. 2020-17 adopting the annual comprehensive street plan for the ensuing six year period of 2021 through 2026 without modifications. Councilmember Ruth Esparza seconded the motion. Motion carried (7-0).

G. Ordinance No. 2020-20 – Vacating a portion of the city right-of-way commonly known as Horan Road

City Engineer Gary Owen presented the staff report.

Council asked questions.

The Mayor asked for public comment. The following people spoke on the matter:

- Gary Arsenault, Chelan County PUD, stated the PUD has been working cooperatively
 with the WSDOT to solve any issues that the DOT may have with the vacation. Mr.
 Arsenault asked for approval of the roadway vacation.
- 2. Wade Detillion, WSDOT, agreed with what Mr. Arsenault stated, but feels additional time is needed to review.

Additional discussion was held. The City Attorney asked if the City Clerk had received any written objections to the vacation. The City Clerk stated no, she had not received any written objections.

Motion for City Council to approve Ordinance No. 2020-20 vacating a portion of Horan Road in the City of Wenatchee, with the exception that the northerly boundary of the proposed vacation be moved 33 feet to the south. Councilmember Travis Hornby seconded the motion. Motion carried (7-0).

6. Reports.

- a. Mayor's Report. The Mayor reported on the following:
 - Sales tax numbers for May are flat from same time last year, and with the extension of March/April taxes being paid, staff is still trying to get an idea of losses.
 - 2. He and staff met with Chelan County regarding the jail contract. They have proposed a different way for charging for next year which will cause a considerable increase for the city. Work will continue to reach an agreement.
 - 3. Environmental work on Confluence Parkway continues. The Mayor has asked Link Transit to assist, and has an information request to the Port as well, to help close the \$700,000 gap. Work will continue to get the project to the finish line for the next round of grant applications.
 - 4. The Finance Director has begun work on the 2021 budget, and is in the middle of the State audit.
 - 5. Public Works has the street preservation project underway, and the Ninth Street parking lot project is also in process.
 - COVID cases continue to rise. Walmart has closed its doors today until Saturday to sanitize due to 21 employees testing positive for COVID. The Governor issued more changes today. Visitors continue to come to Wenatchee for outdoor recreation. Hotels have been full.

b. Reports/New Business of Council Committees

Councilmember Jose Cuevas reported that he has been working through issues with staff about concession stands in Methow Park.

Councilmember Mark Kulaas reported that the Museum Board met this week and they are struggling with everything. They appreciated the assistance of Executive Services Director Merrill with revising the contract with the city to comply with the grant they have received to redo the exhibit area.

Councilmember Ruth Esparza reported that the Health District will be asking various local agencies for monetary assistance for funding.

III. OVERVIEW

This project was implemented to allow timely restoration of concrete infrastructure during times when the city's maintenance crews were experiencing increased workloads. The contract was in place for one year and was set up on an on-call basis.

I. SUBJECT

Wenatchee City Hall Redevelopment – Project No. 1716 Bid Rejection

II. ACTION REQUESTED

Staff recommends the City Council reject all bids received for the Wenatchee City Hall Redevelopment – Project 1716

III. OVERVIEW

The Wenatchee City Hall Redevelopment went to bid with a \$6,900,000 - \$7,775,000 estimate. The City of Wenatchee has budgeted \$7,800,000, not including contingency, for the construction of the new Wenatchee City Hall. Five bids were received. Upon review of the bids, the lowest responsible bidder is Cascade Central Construction, LLC with a base bid of \$11,338,250.

It appears that COVID-19 may have played a role in disturbing material prices.

IV. FISCAL IMPACT

Rejecting all bids will result in rebid costs. An evaluation of the overall project will be performed in an effort to find value engineering gains with a goal to reduce the scope of the project and the project costs as a whole.

V. PROPOSED PROJECT SCHEDULE


It is Staff's recommendation to wait out the COVID-19 impacts and rebid during a more conducive bidding climate.

Staff recommends the City Council accept the Chelan-Douglas Homeless Housing Task Force's recommendations and authorize the Mayor to:

- Enter into a new grant agreement between the Department of Commerce and the City of Wenatchee for the Low-Barrier Shelter Grant.
- Enter into an amended agreement to increase the funding for the existing CARES Emergency Solutions Grant (ESG-CV) between the Department of Commerce and the City of Wenatchee.
- Enter into an amended agreement for the existing ESG-CV Rapid Rehousing subgrant agreement with the Community Action Council to increase funding as recommended by the Chelan-Douglas Homeless Housing Task Force.
- Enter into new ESG-CV subgrantee agreements with Chelan Valley Hope, the Community Action Council, the People's Foundation, and the Women's Resource Center as recommended by the Chelan-Douglas Homeless Housing Task Force.

III. <u>OVERVIEW</u>

The City of Wenatchee is responsible for administering the Ten-Year Plan to Reduce Homelessness in Chelan and Douglas Counties, pursuant to an interlocal agreement with Chelan County, Douglas County, and the City of East Wenatchee. This includes the distribution of local homeless funds collected by county auditors from recording surcharge fees and funds distributed by the Washington State Department of Commerce through the Consolidated Homeless Grant and the Emergency Solutions Grant, as well as other new emerging funding sources.

The homeless planning and fund distribution processes are guided by the Chelan-Douglas Homeless Housing Task Force (HTF). The HTF is comprised of community representatives and local elected officials from all jurisdictions in Chelan and Douglas Counties.

Item 1: Low-Barrier Shelter Grant

The Department of Commerce has allocated new funding through the Low-Barrier Shelter Grant for the design, development, and operation of a regional low-barrier emergency shelter for Chelan and Douglas counties. The total allocated amount is shown below in Table 1.

The HTF requested that City staff prepare and submit the Low-Barrier Shelter grant application on behalf of Chelan and Douglas counties and the City of East Wenatchee and retain a portion of the funding for the City's grant administration and program management activities as outlined below:

<u>Item 2: CARES Emergency Solutions Grant (ESG-CV) Amendment:</u>

The Department of Commerce is allocating additional funding through the existing CARES Emergency Solutions Grant (ESG-CV). The HTF recommended allocations as listed in Tables 2 and 3 below.

The tables list approximate award amounts based on an estimated award total that has not yet been released by Commerce. Staff requests that the Council authorize the Mayor to sign contracts for services that align with the percentages of the awards listed in the tables below. The specific contract amounts will be revised using those percentages when Commerce releases the final award amounts in late August.

The sources of funds being made available include state and federal funding specifically restricted to homeless and low-income housing eligible activities. Additional funds have been set-aside for City homeless program management activities including administration.

Fiscal impacts to the City include administration and program management costs associated with administering these programs. A certain percentage of grant funds may be spent on City administration and program management expenses. An estimate of these expenses has been submitted for inclusion in the 2020 budget for fund 117 and the Community Development Department. These expenses are reimbursable activities. Chelan Douglas Homeless Program cost impacts to the City's budget are evaluated for indirect costs and then directly for general fund impacts. Minor budget amendments are expected throughout the respective grant terms.

I. SUBJECT

Resolution 2020-24 approving a Development Agreement between the City of Wenatchee and Roland and Dianna Wheeler (Wheeler's)

II. ACTION REQUESTED

Staff recommends the City Council pass Resolution 2020-24 adopting the Development Agreement between the City of Wenatchee and the Wheeler's and authorizes the Mayor to sign the agreement.

III. OVERVIEW

The details regarding the proposed Development Agreement are as follows:

- A. The Wheelers are applying to Short Plat their property at 2013 Maple Street into 3 lots (see Attachment 1).
- B. As a condition of the Short Plat the City requires the Wheeler's to dedicate right-of-way to the City and construct approximately 235 feet of half-street improvements along the property frontage on Maple Street.
- C. In lieu of installing the street improvements, the Wheeler's have agreed to dedicate 5,319 square feet of right-of-way as shown on Exhibit B in the Development Agreement and pay \$46,970.00 prior to recording the Short Plat. These two conditions satisfy the Wheeler's obligation to improve Maple Street with half-street improvements and relieves them from any further obligations for street improvements.
- D. The City is negotiating a Development Agreement with Triad Development that will have a provision requiring Triad to complete the Maple Street improvements including the 235 feet in front of the Wheeler's property. The dedication of right-of-way from the Wheeler's allow Maple Street to be shifted south and avoid demolishing an existing home on the North side of Maple Street.

E. This Development Agreement provides the assurance to the City and the Wheeler's that the short plat conditions for street improvements along Maple Street have been met.



A RESOLUTION, approving a development agreement between the City of Wenatchee and Roland E. "Sandy" Wheeler and Dianna G. Wheeler.

WHEREAS, Roland E. "Sandy" Wheeler and Dianna G. Wheeler ("Wheelers") are the owners of certain real property located at 2013 Maple Street, Wenatchee, Chelan County, Washington and more fully described on Exhibit "A" attached hereto (the "Property"); and

WHEREAS, Wheelers are applying to the City for approval of a short plat of the Property into three lots ("the Short Plat"); and

WHEREAS, as a condition of approval of the Short Plat, the City requires that Wheelers dedicate right of way to the City and installation of approximately 235 feet of half street improvements along the Property frontage on Maple Street. In lieu of installing the street improvements, Wheelers have agreed to dedicate right of way as shown on the legal description and drawing attached hereto as Exhibit "B". In addition, the City requires that the Wheelers pay to the City the sum of \$46,970 prior to obtaining final approval of the Short Plat and recording thereof. The right of way dedication and the cash payment shall relieve the Wheelers from any further obligation to participate in the Maple Street improvements in mitigation of the impacts of the Short Plat.; and

WHEREAS, the City and Wheelers have reached an agreement with respect to the dedication of right of way and cost sharing in the form of a development

agreement; and

WHEREAS, Chapter 36.70B RCW authorizes the City to enter into development agreements setting forth the development standards and other provisions that apply to and govern the development; and

WHEREAS, a duly advertised public hearing was held before the City Council on August 13, 2020.







THIS DEVELOPMENT AGREEMENT ("Agreement") is entered into by and between the City of Wenatchee, a Washington municipal corporation ("City") and Roland E. "Sandy" Wheeler and Dianna G. Wheeler, husband and wife ("Wheelers"). The City and Wheelers may hereafter be collectively referred to as the "Parties" or individually as a "Party."

RECITALS:

A. Wheelers are the owners of certain real property located at 2013 Maple Street, Wenatchee, Chelan County, Washington, legally described on Exhibit "A" attached hereto and incorporated herein by this reference ("the Property").

- B. Wheelers are applying to the City for approval of a short plat of the Property into three lots ("the Short Plat").
- C. As a condition of approval of the Short Plat, the City requires that Wheelers dedicate right of way to the City and installation of approximately 235 feet of half-street improvements along the Property frontage on Maple Street. In lieu of installing the street improvements, Wheelers have agreed to dedicate right of way as shown on the legal description and drawing attached hereto as Exhibit "B". In addition, the City requires that the Wheelers pay to the City the sum of \$46,970 prior to obtaining final approval of the Short Plat and recording thereof. The right of way dedication and the cash payment shall relieve the Wheelers from any further obligation to participate in the Maple Street improvements in mitigation of the impacts of the Short Plat.
- D. Any and all utility extension costs necessary to serve the Short Plat shall be at Wheelers' expense.
- E. The City is negotiating a development agreement with Triad Maple, LLC ("Triad") that is anticipated to have a provision requiring Triad to complete the Maple Street improvements fronting Wheelers' Short Plat and to the West thereof. The City makes no representations or guaranties, and the Wheelers are relying on no such representations, as to when the improvements to Maple Street will be made.

AGREEMENT:

NOW, THEREFORE, in consideration of partial satisfaction of the conditions of approval of Wheelers' Short Plat application the City and Wheelers agree as follows:

- 1. Recitals. The foregoing recitals shall be and hereby are incorporated in this Agreement as if set forth in full herein.
- 2. <u>Ownership</u>. Wheelers warrant that they are the owners of the real property described in Exhibit "A" and that they have the full and complete authority to enter into this Agreement with the City for the purposes set forth herein.
- 3. <u>Dedication</u>. Wheelers agree to immediately dedicate to the City a portion of the Property for public right of way as described and shown on Exhibit "B" attached hereto. Title to the right of way shall be conveyed by Wheelers to the City as right of way by statutory warranty deed free and clear of all defects and encumbrances not materially impacting the intended use of the public right of way for the City. The City shall require a release of the deed of trust in favor of Cashmere Valley Bank recorded at Chelan County AFN 2514154 as it relates to the right of way being acquired as described and shown on Exhibit "B" prior to accepting the deed and granting final approval of the Short Plat.
- 4. <u>Payment</u>. Wheelers shall pay to the City the sum of \$46,970 prior to obtaining final approval of the Short Plat and recording thereof. The payment is for the Wheelers proportionate share of the Maple Street sewer main extension and the said half-street improvements. Because the Wheelers are paying for

their proportionate share of the Maple Street sewer main, any proposed sewer connection from the Wheeler property will not be subject to a Local Facilities Charge per WCC 4.08.036(2)

- 5. <u>In Lieu</u>. The right of way dedication and the cash payment is in lieu of and shall relieve the Wheelers from any further obligation to participate in the Maple Street improvements in mitigation of the impacts of the Short Plat.
- 6. <u>Utility Extensions</u>. Any and all utility extension costs necessary to serve the Short Plat shall be at Wheelers' sole cost and expense.
- 7. <u>Private Access Standards</u>. The Public Works Department will support a proposed alternative design to the short plat private road standards and waive the requirement for curbs along the edges of the private access paving provided that the Wheeler's submit an Alternative Request that meets the criteria outlined in WCC 11.20.020(14).
- 8.. <u>Notices</u>. Any notices to be given hereunder by either Party may be effected either by personal delivery, in writing, or by mail, registered or certified, postage prepaid, with return receipt requested. Notices delivered personally shall be deemed communicated as of actual receipt, mailed notices shall be deemed communicated three (3) days following the date of mailing, All notices shall be sent to the following address, unless actual notice in writing of a different address for notices is received by the other Party:






