Action Requested: Staff recommends that the City Council award the construction contract for the 2021 Damaged Luminaire Replacements, Project No. SW20-10, to Midland Electric, Inc. in the amount of \$168,902.00 and authorize the Mayor to sign the contract documents.

If there are a large number of speakers, a representative may be appointed to speak on behalf of the group.
