I. CALL TO ORDER

Chair Luis Gonzalez called the meeting to order at 5:44 p.m. with the following board members in attendance: Adriana Farnsworth and Amber Hallberg. City staff was represented by: Cliff Burdick, Building and Fire Code Official, Eric Mudgett, Code Compliance Officer, Kevin Kinman, Code Compliance Officer, and Yolanda Garcia, Code Compliance Coordinator.

II. ADMINISTRATIVE AFFAIRS

A. Approval of the minutes from the last regular meeting on December 14, 2021.

Board member Amber Hallberg moved to approve the minutes of the regular meeting of December 14, 2021. Board member Adriana Farnsworth seconded the motion. The motion carried.

B. Election of 2022 Officers

Board member Amber Hallberg moved to recommend Luis Gonzalez continue as Chair of the board for 2022. Board member Adriana Farnsworth seconded the motion. The motion carried.

<u>Board member Luis Gonzalez moved to recommend Amber Hallberg as Vice Chair for 2022.</u>
Board member Adriana Farnsworth seconded the motion. The motion carried.

IV. NEW BUSINESS

Chair Luis Gonzalez provided an explanation of public hearing procedures and the appearance of fairness.

Chair Gonzalez swore in City Staff.

A. 21-744 – 916 Cherry Street – Roberto Guerrero

Kevin Kinman, Code Compliance Officer, and Cliff Burdick, Building and Fire Code Official, presented the staff report.

The respondent Roberto Guerrero was present via telephone conference to address the Board and violations.

Mr. Guerrero agreed with the city regarding the violations at his property, but due to having COVID he requested additional time to bring his property into compliance.

Chair Gonzalez closed the hearing and opened deliberations of the Board.

Board member Amber Hallberg moved that the Board, having heard the case and facts presented, find that the respondent is in violation of Wenatchee City Code and that a mandatory fee of \$150.00 be imposed. Board member Adriana Farnsworth second the motion. The motion carried.

Board member Adriana Farnsworth moved that the respondent be given until the 9th of February, 2022, to correct the violations of the Wenatchee City Code. After the 9th of February, 2022, a monetary penalty of \$100.00 per day shall be imposed for each code violation, for a period of 30 days, or until the violation has been corrected, for each code violation. If the time frame expires and the property is still in violation, the Board authorizes the City to abate the violation. Board member Amber Hallberg seconded the motion. The motion carried.

B. 21-721 - 1039 1st Street - John Shattuck

Kevin Kinman, Code Compliance Officer, and Cliff Burdick, Building and Fire Code Official, presented the staff report.

The respondent John Shattuck was present to address the Board and violations.

Mr. Shattuck stated he has been having health issues and requested additional time to bring property into compliance.

Chair Gonzalez closed the hearing and opened deliberations of the Board.

Board member Amber Hallberg moved that the Board, having heard the case and facts presented, find that the respondent is in violation of Wenatchee City Code and that a mandatory fee of \$150.00 be imposed. Board member Adriana Farnsworth second the motion. The motion carried.

Board member Adriana Farnsworth moved that the respondent be given until the 9th of February, 2022, to correct the violations of the IPMC 2018 308.1 for Accumulation of Rubbish and Garbage and the 10th of March, 2022 to correct the violations of the IPMC 2018 302.4 and 302.8 for weeds and motor vehicles. After the 9th of February and the 10th of March, 2022, a monetary penalty of \$100.00 per day shall be imposed for each code violation, for a period of 30 days, or until the violation has been corrected, for each code violation. If the time frame expires and the property is still in violation, the Board authorizes the City to abate the violation. Board member Amber Hallberg seconded the motion. The motion carried.

C. 21-571 – 417 ½ Kittitas Street – Sara Ornelas

Eric Mudgett, Code Compliance Officer, and Cliff Burdick, Building and Fire Code Official, presented the staff report.

The respondent Sara Ornelas and her daughter Maria Sanchez were present to address the Board and violations.

Ms. Sanchez stated they've had a difficult time finding a designer. Ms. Sanchez started working with designer Abe Lopez, but didn't work out. They're working with a designer at the moment. Ms. Sanchez requested additional time to submit and obtain the building permit required for their project.

Chair Gonzalez closed the hearing and opened deliberations of the Board.

Board member Amber Hallberg moved that the Board, having heard the case and facts presented, find that the respondent is in violation of Wenatchee City Code and that a mandatory fee of \$150.00 be imposed. Board member Adriana Farnsworth second the motion. The motion carried.

Board member Adriana Farnsworth moved that the respondent be given until the 31st of March, 2022, to correct the violations of the Wenatchee City Code. After the 31st of March, 2022, a monetary penalty of \$100.00 per day shall be imposed for each code violation, for a period of 30 days, or until the violation has been corrected, for each code violation. If the time frame expires and the property is still in violation, the Board authorizes the City to abate the violation. Board member Amber Hallberg seconded the motion. The motion carried.

D. 21-704 – 808 Ferry Street – Marco Gonzalez

Eric Mudgett, Code Compliance Officer, and Cliff Burdick, Building and Fire Code Official, presented the staff report.

The respondent Marco Gonzalez and Ray Perez (general contractor) were present to address the Board and violations.

Due to COVID and the fact that an engineer is currently working on the construction plans; Mr. Perez requested additional time to submit and obtain the building permit required for Mr. Gonzalez's project.

Chair Gonzalez closed the hearing and opened deliberations of the Board.

Board member Amber Hallberg moved that the Board, having heard the case and facts presented, find that the respondent is in violation of Wenatchee City Code and that a mandatory fee of \$150.00 be imposed. Board member Adriana Farnsworth second the motion. The motion carried.

Board member Adriana Farnsworth moved that the respondent be given until the 28th of February, 2022, to correct the violations of the Wenatchee City Code. After the 28th of February, 2022, a monetary penalty of \$100.00 per day shall be imposed for each code violation, for a period of 30 days, or until the violation has been corrected, for each code violation. If the time frame expires and the property is still in violation, the Board authorizes the City to abate the violation. Board member Amber Hallberg seconded the motion. The motion carried.

E. 21-691 – 836 Methow Street – Jose Sandoval

Eric Mudgett, Code Compliance Officer, and Cliff Burdick, Building and Fire Code Official, presented the staff report.

The respondent was not present to address the Board and violations.

Chair Gonzalez closed the hearing and opened deliberations of the Board.

Board member Amber Hallberg moved that the Board, having heard the case and facts presented, find that the respondent is in violation of Wenatchee City Code and that a mandatory fee of \$150.00 be imposed. Board member Adriana Farnsworth second the motion. The motion carried.

Board member Adriana Farnsworth moved that the respondent be given until the 9th of February, 2022, to correct the violations of the Wenatchee City Code.
