A. Approval of the minutes from the last regular meeting on January 26, 2022.

Board member James Snyder moved to approve the minutes of the regular meeting of January 26, 2022. Board member Adriana Farnsworth seconded the motion. The motion carried.

Vice Chair Amber Hallberg provided an explanation of public hearing procedures and the appearance of fairness.

Vice Chair Hallberg swore in City Staff.

A. 21-752 – 937 Corbaley Place – Mark Snelson and William Snelson

Kevin Kinman, Code Compliance Officer, and Cliff Burdick, Building and Fire Code Official, presented the staff report.

The respondent William Snelson was present to address the Board and violations.

Mr. Snelson stated both of his parents are deceased and is trying to obtain the property through the court. Mr. Snelson brought photos and registrations for some of the vehicles as evidence that he's been working on bringing the property into compliance. He stated he's taken six (6) loads to the dump as well.

After some discussion board members commended Mr. Snelson for all the hard work he's invested in bringing the property into compliance.
