Re: Initiation of Confluence Parkway Environmental Assessment

The Federal Highway Administration, WSDOT Local Programs, and the City of Wenatchee are initiating the environmental review process as an Environmental Assessment (EA) for the Confluence Parkway Project. Cooperating agencies, participating agencies, and interested Tribes are as follows:

This project proposes to build a 2.5-mile, two-lane arterial street that would begin on Euclid Avenue just north of Penny Road, bridge the Wenatchee River, and extend south to Miller Street. The parkway would have one 11-foot-wide travel lane in each direction with other features, such as railroad underpass, left-turn pockets, intersection re-configurations at Miller, Wenatchee Avenue and Maple Street, sidewalks, and pedestrian/bicycle facilities, varying by location. The project is located in Wenatchee, Washington, 98801. The estimated cost of the project is approximately \$123 million. More information can be found at www.wenatcheewa.gov/confluenceparkway.
