DEPARTMENT OF PUBLIC WORKS STREETERY PERMIT

The Wenatchee City Council has passed Ordinance No. 2020-22, creating regulations and permit requirements for private use of City streets and sidewalks for streeteries.

Formal Application Process for Streetery

The application shall include:

- 1. Please complete Temporary Use Permit Application "Outdoor Seating."
- 2. Letter of support from the Wenatchee Downtown Association;
- 3. Proof of Liquor Control Board application and Health District approval if applicable;
- 4. A detailed site plan of the final design of the Streetery detailing the location of existing street features, such as fire hydrants, sidewalk width, trees, catch basins, street lights, etc.;
- 5. An operational plan illustrating ADA compliant ingress and egress along with safety features to protect users and the structure.
- 6. Structural plan if applicable;
- 7. Aesthetics plan (visuals) and sample materials if necessary to illustrate he proposed look and feel intended;
- 8. Proof of insurance; with limits no less than five hundred thousand dollars per occurrence
- 9. Security device; if permittee intends to permanently secure something to City right of way, the security device shall be in the amount of one thousand dollars.
- 10. Proof of City business license.

Steps for approval of a Steetery Permit Application

- Once the application is deemed complete, the applicant will present the design and aesthetic
 information to the Planning Commission for design review. The Planning Commission meets
 monthly on the 3rd Wednesday of the month. The Planning Commission will make a
 recommendation to the Community Development Director about the aesthetics and either
 approve, deny, or recommend modifications of aesthetics.
- 2. The City will provide notice to property owners within 300 feet of the proposed streetery location
- 3. The Community Development Director will make the final approval determination in consultation with the Mayor, Public Works Director, Police Chief, and Parks and Recreation Director
- 4. Upon approval and prior to issuance of the streetery permit the applicant shall pay a one-time fee in accordance with Chapter 1.99 WCC. Any change to the use requiring City approval shall constitute a new application and is subject to a new one-time fee, including change of ownership.
- 5. A right of way permit will be issued for installation/construction to start.
- 6. Once payment is received a hold harmless agreement approved by the City wherein the applicant agrees to defend, save and hold harmless the City of Wenatchee will be issued.
- 7. Inspections will be required during the construction process by Public Works staff.
- 8. Streeteries may be required to be removed during the winter to allow for snow plowing.

Conditions of Streetery Permit

- 1. No alcoholic beverage may be served or consumed within the permit area, except under the following conditions:
 - Any establishment seeking to extend outside liquor services shall comply with all applicable Washington Liquor and Cannabis Board regulations, including but not limited to WAC 314-02-130 and WAC 314-03-200
 - b. City of Wenatchee currently has demarcations to place on the sidewalk in lieu of having to install a 42-inch barrier. Must notify LCB demarcations will be in use when applying for outdoor liquor license. Please see exhibit below for demarcation example.
 - c. All Liquor and Cannabis Board regulations including regulations relating to "extended outside service areas" shall be adhered to;
 - d. A breach of any of the foregoing conditions shall be grounds for immediate suspension or termination of the permit pursuant to subsections (f) of this section;
- 2. The entire sidewalk, including both the permit area and the unobstructed pedestrian corridor, plus a distance of fifty feet either side thereof, shall be maintained in a clean and litter-free condition and shall be cleaned by the permittee no less than once daily;
- 3. The minimum height for umbrellas and other shade devices shall be seven feet in order to provide unobstructed passage for pedestrians;
- 4. No food preparation shall take place within the permit area.

STREETERY PERMIT APPLICATION

General Provisions

Permit No.:	Site Address:

- 1. The activity authorized by this permit shall terminate on December 31st unless renewed.
- 2. Private use of Public space shall be limited to the following activities outdoor seating for restaurants, coffee shops, or similar uses.
- 3. The licensee must comply with all applicable federal, state and City of Wenatchee laws and regulations and the private use of public space shall not be detrimental to the health, safety, or welfare of persons residing, working, or patronizing in the vicinity.
- 4. The use of the public sidewalk or right of way for private use is only permitted where adjoining sidewalk is a minimum width of ten (10) feet.
- 5. The operation of the private use cannot interfere with the passage of pedestrian or vehicular traffic, or reduce the open portion of the public walk to less than five (5) feet clear of all obstructions.
- 6. The use of the public sidewalk or right of way for private uses is only permitted when incidental to the operation of a licensed restaurant, coffee shop, or similar use, on private contiguous property and only along the frontage of the subject property.
- 7. No furniture, furnishings, or fencing may be attached by any means to the public sidewalk or any public property. Unless approved by the Public Works Department.
- 8. No electrical appliances or conductors, open flame devices, spill able petroleum products or other flammable liquids shall be placed or kept in the outdoor seating area.
- 9. This temporary permit for private use of the public space shall not constitute a property right and the City of Wenatchee shall retain at all times the right to terminate any permit for use of any public property upon thirty (30) days written notice to the license / permit holder(s).
- 10. The Grantee, its successors and assigns, agrees to protect the City of Wenatchee, their officers and employees and save them harmless from all claims, actions or damages of every kind and description which may accrue to or be suffered by any person, persons, or property by reason of the acts or omissions of the Grantee, its assigns, agents, contractors, licenses, employees or any person whomsoever, in connection with Grantee's, its assigns', contractors', licensees' or employees' construction, installation, maintenance, operation, use of occupancy of the right of way or in the exercise of this permit. In case any suit or action is brought against the City of Wenatchee, their officers or employees, arising out of or by reason of any of the above causes, the Grantee, its' successors or assigns will, upon notice of such action, defend the same at its sole cost and expense and satisfy any judgment against the City of Wenatchee, or their officers or employees: PROVIDED, that if the claims or damages are caused by or result from the concurrent negligence of (a) the City of Wenatchee's agents or employees and (b) the Grantee or Grantee's agents or employees, this indemnity provision shall be valid and enforceable only to the extent of the negligence of the Grantee or the Grantee's agents or employees.
