Overview

The Confluence Parkway (Project) aims to address transportation problems in the North Wenatchee area and prepare for traffic growth by creating a parallel route to N Wenatchee Avenue, which also provides grade separated railroad crossings and a new bridge across the Wenatchee River. The Project will also impact a portion of the Apple Capital Loop Recreation Loop Trail (Trail).

As part of the ongoing community outreach effort, the City organized a site walk "Let's Loop Together Tour" (Tour) along the existing Trail to educate interested stakeholders on the proposed improvements.

Outreach materials

Various materials were developed as part of the outreach effort. The following outlines the notifications, tools, and physical materials that were used throughout the outreach process.

a. Notifications

- <u>Flyer/Share Post Graphic</u> (Appendix A) in both English and Spanish was circulated to inform the public of the upcoming Tour and direct online traffic to the project website.
- <u>Social Media</u> (Appendix B) posts in both English and Spanish were used to advertise the event, project
 website, and share general project information on multiple platforms. Posts were shared on The City of
 Wenatchee's Facebook page, The Wenatchee World's Facebook page, and on the City's Twitter page.
 These posts encouraged interaction with the public through information, sharing stories and general
 commentary.
- Radio and Paid Adverting: (Appendix C) City staff and elected officials appeared on a variety of local radio shows to discuss the Project and advertise the tour in addition to paid ads.
- <u>Email updates:</u> Emails were sent out to specific community members and groups who frequently recreate on the Trail (over 250 users) asking them to participate in the Loop tour or share their stories on how they use the Trail. Additionally, a follow up email was sent with a video that shared highlights from the tour after the event and a call to take the PUD survey.

b. Tools

- An online project website is currently hosted on the City of Wenatchee's website. The website was
 updated to include details of the upcoming Tour, including time, date and purpose. The site allows
 community members to provide feedback and comments through an online form.
- Editorials: (Appendix D) Four editorials were submitted and published by the Wenatchee World regarding
 the Project from Link Transit, Ballard Ambulance, North Central Washington Audubon Society, TREAD
 and Mayor Frank Kuntz. The editorials were published in the print and online version of the Wenatchee
 World.
- Concurrently, the Chelan County Public Utilities Districted #1 (PUD) released a survey to collect feedback
 on the proposed improvements and mitigation. The City's marketing, messaging, and materials
 encouraged residents to submit written feedback through the PUD Survey Monkey link. A recap of the
 survey responses received is included as Appendix E.

 discussed proposed design considerations.
- Comments recommending a phased reconstruction of the Trail to avoid user impacts during construction.
- Questions regarding how noise and other impacts will be mitigated, staff discussed proposed design considerations.



Wenatchee Valley home understand what an asset it is to our community to have the Apple Capital Recreation Loop Trail.

For me it is access to a year-round safe place to exercise and nourish my soul. It is a connection to the wild places that I

crave when winter trail closures keep me out of Sage Hills and deep snow prevents access to the mountains. Like an old friend, it is always there.

I recognize the privilege I enjoy every time I step on this trail. I marvel at the tireless efforts of community leaders like Bob Parlette and Joan VanDivort whose shared vision and passion turned the town dump into the Wenatchee Valley's crown jewel.

The improvements proposed within the Confluence Parkway Project, in my mind have the potential to enhance the experience of trail users like myself. I especially like the idea of moving the path away from the roadway and below the current Chelan County PUD shops. This buffer creates separation from the busyness of the outside world, allowing a more immersive natural experience.

The Confluence Parkway Project, as proposed, supports the original visioning for the 10-mile Loop and extensions, promising to improve access and quality of life for all of us with better pedestrian routes from surrounding neighborhoods. I am especially excited about the potential to build on this trail network with trails to the west along the Wenatchee River, connecting Wenatchee to Cashmere and Leavenworth. Confluence Parkway will not do that work, but it sets the stage for

future trail expansion. I also have hope this project may make it easier and more convenient for commuters to leave their cars at home during the afternoon and morning commute. While it might seem counterintuitive to expect fewer people in personal vehicles with the construction of yet another bridge, it is my hope that the options presented by this project actually make it more attractive to use public transportation, ride a bicycle, or even walk to and from work.

As with all public projects, there are tradeoffs. Safer access could mean a longer distance to trail access for some of us. The Confluence Parkway Bridge is engineered to share with pedestrians, which is less than ideal for those of us used the current alignment. The construction phase will have its inevitable noise impacts and traffic disruptions.

But the good it can do potentially outweighs these side effects. The project comes with a \$10 million

investment in improved access to the Loop Trail, an opportunity to improve habitat by bringing more water and four more acres to the Horan Natural Area and a new electric bus rapid transit service. And anyone who has driven North Wenatchee Avenue during busy commute times is aware of the need to take the pressure off of this major corridor. The Confluence Parkway Project does that.

I am excited about the Confluence Parkway vision for the Wenatchee Valley. I look forward to it introducing many more generations to the benefits of access to the beautiful spaces the Apple Capital Recreation Loop Trail provides. I look forward to living in a pedestrian-friendly city that connects all of us to this invaluable natural space. I encourage our leaders to remember and consider the words of Bob Parlette as he described how our collective relationship with the Columbia River has evolved:

'When I came to town, I wanted to go down to the river. I went to the bottom of Fifth Street, and there was a big fence there and a 'Do No enter' sign. I just couldn't believe there was no way to access the river. Now when I go down to the riverfront, it gladdens my heart to see people riding bikes and smiling at each other as they walk on the trail. For decades, we had our backs to the river, and today we have turned our faces to the

Let's keep our faces to the river, respect the vision that gives us the privileged access we enjoy today and continue to make it easier for all of us to share in this amazing legacy. The Confluence Parkway Project is one giant leap in this direction and I look forward to its completion.

The annoyance of sitting in the bottleneck of North Wenatchee can be so frustrating as we enter or exit the north end of Wenatchee. Cars everywhere, bumper to bumper, as we inch

forward to our destination. In the world of Emergency Services this annoyance can have challenges many might not think of. Responding to emergency calls on the north end of town during rush hour is a stressful and dangerous task for emergency crews. Driving with lights and sirens activated is arguably

the most consistent daily risk/liabili-

ty that emergency crews deal with.

On a good day, with minimal traffic it is challenging enough to respond to calls. The law requires that drivers yield for emergency vehicles. Stop and pull to the right is what we were all taught in driver's education. How on earth is that accomplished in the midst of the north-end congestion? Often the only way for emergency vehicles to get through the traffic is to pull out into turn lanes or sometimes even into oncoming traffic lanes. This increases the risk to everyone on the road.

Getting to calls is only part of the job for emergency crews. What about getting patients back to the hospital? Think of how arduous it is to fight through the congestion coming into the north end. Frustrated. Annoyed. Irritated. Those are probably the emotions most people are experiencing while driving in or out of town. EMS crews transporting sick and injured people to emergency rooms have a different perspective and different emotions. Fear: Are we going to get our patient to the hospital in time? Anxiety: How am I going to navigate this horrible mess of traffic with a critically ill patient in the back? When dealing with sick and injured patients, time can be very precious. Delays can have tragic consequences.

We in emergency services welcome the Confluence Parkway. The additional access point for emergency crews is going to improve public safety in emergency situations. Response times to calls and transports to the emergency departments will be safer, quicker, and more efficient. We look forward to having the infrastructure in place to better serve the community in an emergency.

Horan Nature Reserve is an important sustainable resource

Currently, there are two major planning efforts underway that stand to influence the social, environmental, and cultural character of the Wenatchee Valley. The city of Wenatchee is planning a major transportation project, the Confluence Parkway. The Chelan County PUD is in the initial stages of relicensing the Rock Island Dam with the Federal Energy Regulatory Commission (FERC). These projects overlap on the land and, to a degree, over time.

Both projects, if implemented, offer opportunities to improve cultural, ecological, social, and educational conditions in an area that the North Central Washington Audubon Society (NCWAS) places high value on: the Horan Natural Area (HNA).

NCWAS in 2018 prepared a vision of desirable future conditions within the HNA. We have continued to advocate for these improvements during the ensuing time. We believe that major improvement can be accomplished in the HNA if the city and PUD closely coordi-

nate their efforts.

The Horan Natural Area is unique in the Wenatchee valley. Historically, the area was of special significance to the p'Squosa/Wenatchi people who resided in the area spanning both sides of the Columbia River. Today, there is no visible evidence of this important cultural use within the HNA. The city and PUD projects provide a chance for tribal leaders to design a meaningful representation of their history within the HNA.

The Horan Natural Area is a "made environment." The natural Wenatchee River delta that extended far into the Columbia River is largely under water impounded by Rock Island Dam. The land we know as the HNA today has been altered over time and now contains a set of constructed ponds that are drying up due to termination of surface water supply to the area. The value of wildlife and bird habitat, as well as the aesthetics of the area, has shrunk along with the ponds. The City and PUD projects offer a chance to re-establish a viable, flowing water supply to, and within, the HNA.

Weeds are common throughout the valley and are well established in the HNA. Valuable native plants, including important cultural species (dogbane, milkweed) compete for survival with the weeds and introduced plant species. Vegetation management in the area is largely custodial. A comprehensive vegetative management plan is needed. The two planning efforts can set the framework to make that happen.

Use of the HNA area by birders, walkers, runners, and watercraft is increasing. The area is used for bilingual environmental education purposes. Previous input to the PUD clearly shows that the natural setting, including its wildlife and birds, is extremely important to them.

The NCWAS continues to promote the idea that the HNA can represent a world-class park that provides valuable educational and recreational opportunities as well as bird and wildlife habitat. The city and PUD planning timeframes overlap today. NCWAS supports the Confluence Parkway and FERC relicensing projects. It is critical that the importance of the value of the HNA for the future of the Wenatchee valley is carefully coordinated between the two entities. Residents and visitors to the Wenatchee valley will be well served when the Horan Natural Area evolves into an ecologically and socially sustainable resource.






Q1: How much do you know about the Confluence Parkway project?






Q2: How often do you visit Confluence State Park or the Horan Natural Area?

Q8: Proposed "combined" Confluence Parkway and pedestrian bridge (increasing from 8 feet wide to 16 feet wide) crossing the Wenatchee River, east of the historic railway bridge. The existing pedestrian bridge is proposed for removal as part of this design.





Q9: Proposed exchange of nearly 6 acres of land to accommodate the Confluence Parkway alignment, including land removed from the park boundary along the railroad and nearly equivalent amount of land replaced to the park along the southern border of the Horan Natural Area.


