MINUTES

I. CALL TO ORDER

Member Steve Clem moved to authorize the City of Wenatchee to utilize Homeless Funds for the purchase of a share, approximately 38% of the parcel at 3240 Highway 97A. This amount is estimated at \$500,000 and could increase or decrease based upon the final appraisal for the property, as provided in staff's presentation. Member Jackie Weber seconded the motion. The motion carried unanimously.

ii. Wenatchee Rescue Mission: Amendment to comprehensive low-barrier shelter grant to accommodate early opening of RV Safe Park 2 and additional staffing.

Member Shayne Magdoff moved to accept the revisions to the proposed contract with the Wenatchee Rescue Mission for the amended contract amount of \$2,090,554.36. Member Steve Clem seconded the motion. The motion carried unanimously.
