## 5:15 p.m. Regular Meeting

**1. Call to Order, Pledge of Allegiance, and Roll Call.** Mayor Frank J. Kuntz called the regular meeting to order at 5:15 p.m. Councilmember Top Rojanasthien led the Pledge of Allegiance. All Councilmembers were present, with Councilmember Keith Huffaker participating via Microsoft Teams.

## 2. Citizen Requests/Comments

Sam Mills, 1020 Appleland Drive, Wenatchee, and downtown property owner, addressed the Council with his concerns about vandalism and damages to downtown properties.

Mike Salmon, 919 First Street, Wenatchee, expanded on what Sam Mills said and asked what property owners can do to prevent this from happening and to feel safe?

Rufus Woods, 429 King Street, #333, Wenatchee, addressed the Council in support of appointing Laura Gloria as City Administrator, and she is the right person for the job, providing greater stability and professionalism moving forward.

Bart Clennon, Wenatchee, thanked the Mayor and Council for the work they have done and spoke in support of the City Administrator position and read a brief statement.

Steve Maher, 104 Monroe, Wenatchee, addressed the Council and concurred with Rufus and Bart, appointing Laura Gloria to the City Administrator role.

James McLaughlin, 2020 Center Court, Wenatchee, addressed the Council with his concerns that the city is not going in the right direction, and the need for more transparency and accountability, and his concerns with homeless and crimes, and the need for more officers.

Edwin Fonseca, business owner at 845 South Mission and 300 Stevens Street, stated the problems he is facing at his businesses have gotten 10 times worse since he last addressed the Council.

Denise McBurnie, 930 Wheeler Road, Wenatchee, addressed the Council regarding her missing son and changing policy and procedure with the Wenatchee Police Department. The Mayor mentioned there will be a search conducted next Tuesday, and the Police Chief is working with the State Patrol to see if existing policy meets State guidance and will bring forward to the City Council if changes are necessary.

Steve Wilkinson, 211 Sienna Road, Wenatchee, and Chamber of Commerce Executive Director, spoke in support of the City Administrator position, which he believes will set up the Mayor and Council for greater success. He also mentioned that the Chamber and Our Valley Our Future are also working on homeless and public safety issues and that South Wenatchee is in need of a lot of attention.

**B.** 2024-2030 Parks, Recreation and Open Space Comprehensive Plan

Parks, Recreation & Cultural Services Director David Erickson presented the staff report. Council asked questions and commended David Erickson for his great work.

Motion by Councilmember Top Rojanasthien for City Council to approve Resolution No. 2023-25, adopting the 2024-2030 Parks, Recreation and Open Space Comprehensive Plan. Councilmember Linda Herald seconded the motion. Motion carried (7-0).

C. Wastewater Treatment Plant Primary Effluent Pipe Emergency Repair Project No. 2324

WWTP Supervisor Mike Hodgson and Deputy Public Works Director-Utilities Jessica Shaw. Council asked questions.

Motion by Councilmember Mark Kulaas for City Council to approve Resolution No. 2023-23 regarding the Wastewater Treatment Plant primary effluent pipe emergency and authorize the Mayor's signature. Councilmember Top Rojanasthien seconded the motion. Motion carried (7-0).

**D.** Wastewater Treatment Plant Influent Pump Replacement, Project No. SW23-01 Authorization to Award Construction Contract

WWTP Supervisor Mike Hodgson presented the staff report.

Motion by Councilmember Travis Hornby for City Council to award the construction contract for the Wastewater Treatment Plant Influent Pump Replacement, Project No. SW2301, to the lowest responsive bidder and authorize the Mayor to sign the contract documents. Councilmember Jose Cuevas seconded the motion. Motion carried (7-0).

E. Wastewater Treatment Plant Digester 4 – Project No. 1810

Senior Engineer-Utilities Jeremy Hoover presented the staff report.

Motion by Councilmember Linda Herald for City Council to amend the construction contract with Apollo, Inc. to pay for the additional work and further authorize the Mayor to approve the construction change order amount of \$156,655.97. Councilmember Travis Hornby seconded the motion. Motion carried (7-0).

**F.** City Project No. SW22-02 – 2024 Damaged Luminaire Replacement Project

Project Engineer Zachary Horton presented the staff report. Council asked questions.

Motion by Councilmember Top Rojanasthien for City Council to award the construction contract for the 2024 Damaged Luminaire Replacement Project, City Project No. SW22-02, to Elite Electrical Contracting, in the amount of \$241,800, and authorize the Mayor to sign the contract documents. Councilmember Travis Hornby seconded the motion. Motion carried (7-0).

**G.** City Project No. 2213 - Millerdale Avenue Canal Bridge - Authorization to Negotiate

Project Engineer Zachary Horton presented the staff report. Council asked questions.

Motion by Councilmember Travis Hornby for City Council to authorize the Mayor to negotiate with KPG Psomas for design services for the Millerdale Avenue Canal Bridge, City Project No. 2213, and authorize the Mayor to sign a contract on behalf of the City of Wenatchee. Councilmember Mike Poirier seconded the motion. Motion carried (7-0).

H. SW22-06 Sidewalk Panel Replacement Project

Public Works Director Rob Jammerman presented the staff report. Council asked questions.

Motion by Councilmember Linda Herald for City Council to award the construction contract for the Sidewalk Panel Replacement Project No. SW22-06, to JM Pacific Construction, LLC in the amount of \$169,934 and authorize the Mayor to sign the contract documents. Councilmember Jose Cuevas seconded the motion. Motion carried (7-0).

I. City Project SW23-06 – Guardrail Replacement Project

Senior Project Engineer Donald Nelson and Engineering Services Manager Ryan Harmon presented the staff report.

Motion by Councilmember Linda Herald for City Council to award the construction contract for the Guardrail Replacement Project, City Project SW23-06, to the lowest responsive bidder and authorize the Mayor to sign the contract documents. Councilmember Top Rojanasthien seconded the motion. Motion carried (7-0).

J. City Project No. 2405 – South Wenatchee Avenue Corridor Study

Public Works Director Rob Jammerman presented the staff report. Council asked questions.

Motion by Councilmember Travis Hornby for City Council to authorize the Mayor to negotiate with Fehr and Peers for services for the South Wenatchee Avenue Corridor Study, City Project No. 2405, and authorize the Mayor to sign a contract on behalf of the City of Wenatchee. Councilmember Jose Cuevas seconded the motion. Motion carried (7-0).

Councilmember Travis Hornby seconded the motion. Motion carried (6-1; Huffaker nay).

Motion by Councilmember Travis Hornby for the City Council to approve Ordinance No. 2023-13 amending Section 1.06.040 of the Wenatchee City Code related to the salary of the mayor. Councilmember Top Rojanasthien seconded the motion. Motion carried (7-0).

Motion by Councilmember Linda Herald for the City Council to approve Ordinance No. 2023-14 amending Sections 1.06.020, 1.07.060 and 1.07.080, and repealing Section 1.06.030 of the Wenatchee City Code relating to administrative functions of the City Council. Councilmember Travis Hornby seconded the motion. Motion carried (7-0).

L. Employment Agreements for Director of Finance, Police Chief, Director of Public Works, Director of Community Development, Director of Human Resources, Director of Parks, Recreation and Cultural Services, Director of Information Technology, and City Administrator

City Attorney Danielle Marchant presented the staff report. Council asked questions and commented.

Councilmember Jose Cuevas seconded the motion. Motion carried (6-0).
