1. Call to Order, Pledge of Allegiance, and Roll Call. The Mayor called the meeting to order at 5:15 p.m. Wenatchee Valley College President Dr. Famous Harrison led the Pledge of Allegiance. All Councilmembers were present.

2. Citizen Requests/Comments

Cindy Volyn, 60 Sage View Lane, Wenatchee, spoke in support of Ordinance 2024-06 and asked for more clarity in descriptions.

David Kelts, President of the Wenatchee Valley Misawa Sister City Association, announced that a delegation from Misawa will be visiting May 1-6 (8 adults and 20 students). Since the sister city relationship was formed in 1982, there have been a total of 836 delegates from Misawa to the Wenatchee Valley, and a total of 591 delegates from Wenatchee to Misawa.

Brandon Smith, 1630 North Wenatchee Avenue, addressed the Council with his concerns regarding Ziply taking over LocalTel.

Alexi Granados, PO Box 5345, Wenatchee, and student at Wenatchee Valley College, addressed the Council with his concerns about the increase in drugs in the city. He used to take the bus but does not feel safe taking the bus anymore. Chief Crown addressed some of his concerns and encouraged everyone to report these types of matters to Rivercom.

Bryan Sanchez, a student at Wenatchee Valley College, addressed the Council with his concerns about speeding cars on Fifth Street and would like to see the cross walk at Fifth Street near student housing have flashing lights. He is also concerned about the student parking lot being used by homeless individuals and garbage in the lot.

Christy Childs, 1537 Skyline Drive, Wenatchee, voiced her concerns about safety and noise at the Skyline Drive overlook park. She requested that the park hours be changed to daylight hours only, 6am – 8pm, and signage that violators will be fined.

Bryan Campbell, 1837 Jefferson Street, Wenatchee, thanked Chief Crown for his service to the community. Chief Crown is retiring in June.

Jonathan Cruz, Wenatchee Valley College student, said a citizen pulled a gun on him yesterday as he was driving through town near a school. He would like to see more cameras around town, especially by schools.

Wenatchee Valley College President Famous Harrison thanked the Mayor and Council for being there.

Denise McBurnie, 930 Wheeler Hill Road, Wenatchee, provided the Mayor and Council with a highlighted copy of WPD Policy 316 "Missing Persons" and requested a meeting to go over the policy with the entire Council.

A. City Project No. 2320 - Crawford and Okanogan Intersection Improvements Authorization to Negotiate

F. New Services/Independent Contractor Agreement with Chelan County PUD for Off-Duty Overtime Patrols in Walla Walla Point Park and Riverfront Parks

Police Captain Edgar Reinfeld presented the staff report.

Motion by Councilmember Keith Huffaker for City Council to approve and authorize the City Administrator's signature on the Services/Independent Contractor Agreement 24-13427, between the City of Wenatchee and Public Utility District No. 1 of Chelan County, which establishes terms for reimbursement for off-duty employment in designated park areas. Councilmember Jose Cuevas seconded the motion. Motion carried (7-0).

G. City Small Works Project SW24-01 – Long Line Striping Contract Authorization to Award Construction Contract

Public Works Director Rob Jammerman presented the staff report. Council asked questions.

Motion by Councilmember Top Rojanasthien for City Council to award the construction contract for the Long Line Striping contract Project No. SW24-01, to Stripe Rite Inc. in the amount of \$106,768.46 and authorize the City Administrator to sign the contract documents. Councilmember Linda Herald seconded the motion. Motion carried (7-0).

H. City Project No. 2208 – McKittrick Street Improvements (Pershing to Pine) Authorization to Award Construction Contract

Project Engineer Hari Sharma presented the staff report. Council asked questions.

Motion by Councilmember Linda Herald for City Council to award the construction contract for City Project No. 2208 McKittrick Street Improvements (Pershing to Pine) to the lowest responsive bidder, Selland Construction Inc. K. City Project No. 2315 – Red Apple Road (Vista to Miller) Consultant Supplement Agreement for Right of Way Services

Engineering Services Manager Ryan Harmon presented the staff report. Council asked questions.

Motion by Councilmember Jose Cuevas for City Council to authorize the City Administrator to execute Supplement 1 to the contract with SCJ Alliance for City Project #2315 - Red Apple Road (Vista Place to Miller Street). Councilmember Linda Herald seconded the motion. Motion carried (7-0).

6. Reports

a. Mayor's Report. City Administrator Laura Gloria provided the Mayor's report:

- (1) There are currently two engineering internships, a GIS internship and up to 15 additional job openings at the city.
- (2) She asked everyone to safe the date of May 6 for the Convention Center project groundbreaking.
- (3) She gave a shoutout to the city's Code Enforcement and Police Department for their partnership and great work together to abate a property near Lincoln Elementary School.
- (4) The Flywheel Investment Conference is next week, April 17 and 18. Tickets are available for the Council if they want to attend.
- (5) The Mayor met with State Treasurer Mike Pelliciotti this week about the role of the State Treasurer's office.

Councilmember Top Rojanasthien reported that he attended the Community Action Council Board Meeting and the "Empty Bowls" event is coming up at Wenatchee High School and is an important fundraiser for them.

Councilmember Chelsea Ewer attended the Museum Board meeting yesterday and they had a look at the renderings for the building updates and they were very impressive and will bring a lot to the community for interactive spaces.

Councilmember Travis Hornby reported that the Wenatchee Downtown Association has voted to move forward with their strategic plan.

Councilmember Jose Cuevas reported that next week is the Public Safety Committee meeting, and that he has been invited to speak at "Teen Night" next week at the College on Friday, April 19. He also reminded everyone that April 25 is "Chief for a Day" and his niece was chosen to participate.

Councilmember Linda Herald invited everyone to attend the Misawa Welcome Reception which is May 1 at 3:30 p.m. at East Wenatchee City Hall. Afterwards, there is a dinner at the Senior Center and everyone is invited, and she will be hosting. Also, for those interested in traveling as part of a delegation to Misawa this fall, applications are due by May 24th.
