REGULAR AGENDA:

- 1. Minutes from the August 20, 2024 Commission meeting. Commissioner Markhart moved approval of the August 20, 2024 meeting minutes. Commissioner Koski seconded the motion. The motion passed 6-0.
- 2. 2025 Draft Budget. A presentation was provided by Director Erickson on potential 2025 capital construction projects, art projects and other requests. The Pioneer Park sidewalk was included in the preliminary budget. He also provided an overview of the line item budget and made note of some increases including pool operational supplies and utilities, park utilities and vandalism supplies and a decrease in cemetery grave sale revenues. The budget process will continue through November 14.
- Project Updates. Along with the report in the agenda packet, the following updates were provided: P'Squosa Plaza construction is almost complete. The pavers had to be reinstalled due to quality issues. Josh Mathena started work for the City as the Homeless Administrator. Advertising for the Community Art Support Grants is beginning this month. The Skyline Drive Gates have arrived and will be installed in the next month or so. The Kiwanis Methow Park backstop is almost finished. Construction of the George Sellar Bridge fence is set to begin on the 17th. Rock much was added to the Okanogan Community Garden's south slopes. The Graham tile mural is being readied for installation at City Hall. Trees were planted in Lincoln and Memorial Parks.

- **4. Grant report.** A report was included in the agenda packet. The pool grant was closed. Work on the Bighorn Ridge Grant is ramping up with the review appraisal, cultural resources report, phase one site assessment, and purchase sale agreements being prepared.
- **5. City Council items.** A report was included in the agenda packet. Director Erickson reported that the Balsamroot fire restoration agreement was approved and work is underway. The Homewater use permit cancellation was also approved.

6. Commissioner Comments.

Commissioner Harmon had several reports.

- The art banners on North Wenatchee Avenue have been installed.
- The Pedestrian Bridge Extension Project is out to bid with bids due on November 21st and possible award on December 5. The project will be under construction from April 2025 through November 2026.
- The Worthen Street Trail Project construction is set to begin next week. The project will be between Thurston Street and Hale Park and include trail separation and widening, lighting and other features.
- The Sports Foundation is working on goals, financials, a transition plan for Caryl and Bundle Up Fest Planning. Bundle Up is scheduled for January 18th.

Chelan Douglas Developmental Disabilities Grants

The grant provides funding support for the Special Needs Social Program. Presented the \$8,500 request for the 2024/25 program year.

RCO WWRP Local Parks Grant (Bighorn Ridge)

This project will acquire approximately 134 acres in the foothills for non-motorized recreation, education, and habitat purposes. The application ranked 3rd statewide. The contract was received and accepted by the City Council. It was executed by the State. Prepared and submitted a grant report. Ordered the review appraisal, phase one environmental site assessment and cultural resources report. The review appraisal should be finished by the end of the month and the other two reports by the end of Spring 2025. Preparation of the purchase/sale agreement is underway.

Washington Cities Insurance Authority Risk Mitigation Grant

This \$15,776 grant was received to fund half of the Kiwanis Methow Park backstop replacement project. The grant was successful. Prepared and submitted a final billing and report to finalize and close out the grant.

Historic Cemetery Preservation Capital Grant

This project would provide funding to purchase and install section signs and an information kiosk for the Cemetery. The application was for \$23,265. Received notification that the grant was successful. Prepared and submitted a final billing and report to finalize and close out the grant.
